ORDINANCE NO. 2014-041

AN ORDINANCE AUTHORIZING WITHDRAWAL FROM THE SOUTH SUBURBAN JOINT ACTION WATER AGENCY (JAWA) AND RESCINDING ALL APPROPRIATE ORDINANCES

WHEREAS, the City entered into an agreement commonly known as the South Suburban Joint Action Water Agency (JAWA) Intergovernmental Agreement;

WHEREAS, the City appointed a city representative to act as a Director on the Board of Directors of the JAWA;

WHEREAS, the purpose of the Agreement was to facilitate the transmission of approved allocations of lake water by the Agency to the Agency members and such agreement included a feasibility study and imposed significant fiscal obligations upon the members, and specifically the City;

WHEREAS, despite being in operation since 2011, no feasibility study has been completed or submitted to the Board of Directors and there appears to be no plan for a timely completion of the study;

WHEREAS, based on the lack of progress with the project, the City wishes to cease participation with the Agency and seek reimbursement of monies deposited with the Agency for the project;

WHEREAS, withdrawal of membership is subject to approval of the Board of Directors upon written notice of intent to do the same;

WHEREAS, the City has determined that it is not in the best interests of the City to remain a member in the JAWA and approve any additional expenditures;

NOW BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook, and State of Illinois:


The Mayor, or designee, is hereby authorized to prepare and file the necessary documents with the appropriate persons to effectuate the withdrawal of the City from the JAWA. All ordinances in conflict are hereby rescinded.

This ordinance shall be in full force and effect immediately or as otherwise required by law.


