**ORDINANCE NO. 2015-035**

**AN ORDINANCE AMENDING ORDINANCE NO. 2014-044 GOVERNING EMPLOYEE  
AND RETIREE HEALTH CONTRIBUTIONS**

Whereas, the city officials have conducted a review of the escalating cost of health care to the city for non-union employees and evaluated the fiscal impact of the current levels of employee and retiree contributions;

Whereas, the city passed Ordinance No. 2014-044 establishing a schedule of premium contributions for health care;

**NOW AND THEREFORE, BE IT ORDAINED** by the City Council of the City of Blue Island, Cook County, Illinois:

That Section One of Ordinance No. 2014-044 be amended to add the underlined text to the end of the paragraph beginning "Effective January 1, 2016," as indicted below, and this ordinance shall be in full force and effect immediately upon passage or as otherwise required by law:

Effective January 1, 2016 and thereafter, all employees shall contribute 15% of the premium cost for selected health insurance plans. However, employees who elect HMO coverage shall contribute 10% of the premium cost for such plan.
