**A RESOLUTION APPROVING THE ILLINOIS TRANSPORTATION
ENHANCEMENT PROGRAM APPLICATION FOR FEDERAL
FUNDING FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION**

WHEREAS, the Mayor and City Council of the City of Blue Island have heretofore established a continuing Community Development Program to promote the welfare of the City of Blue Island; and

WHEREAS, it is the policy of the City of Blue Island to support community based projects that expand travel choices and enhance the transportation experience by improving the cultural, historic, and environmental aspects of our transportation infrastructure; and

WHEREAS, this policy supports the promotion and development of alternative transportation options, including bike and pedestrian travel, along with streetscape beautification; and

WHEREAS, in furtherance of said policy the Mayor and City Council of the City of Blue Island deem it appropriate to apply for federal funding from the Illinois Transportation Enhancement Program ("ITEP") for the 2016 Program Year for the purpose of improving the general living environment of the City of Blue Island;

WHEREAS, the City intends to apply for \$2 million with a 20% match, which would be funded by the Business Development District ("BDD");

Whereas, an application is required by the Illinois Department of Transportation ("IDOT") and is attached hereto and entitled "2016 ITEP Application."

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Blue Island, County of Cook and State of Illinois:

That the Mayor and the City Clerk of the City of Blue Island support and are hereby directed and authorized to submit the 2016 ITEP Application, all understandings and assurances and to execute all necessary additional documents, and complete all necessary steps to effectuate the purpose of this resolution.
