

**RESOLUTION NO. 2016-044**

**A RESOLUTION DIRECTING AND AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE COUNTY OF COOK FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDED PROJECT #1606-002: STREET RECONSTRUCTION: GREENWOOD AVENUE, ANN AND MARKET STREETS**

**WHEREAS**, the City of Blue Island is desirous of entering into an Intergovernmental Agreement with the County of Cook for the purpose of funding the hereinafter described Community Development Block Grant Project; and

**WHEREAS**, the hereinafter defined project will enhance the residential environment and promote the commercial development within the City; and

**WHEREAS**, the Mayor and City Council of the City of Blue Island are desirous of achieving the aforesaid goals.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and members of the City Council of the City of Blue Island that the Mayor and City Clerk be and are hereby directed and authorized to submit the Subrecipient Agreement, all understandings and assurances and to execute the 2016 Community Development Block Grant Program Year Agreement with the County of Cook, Illinois for Project #1606-002: Street Reconstruction: Greenwood Avenue, Ann and Market Streets, in the amount of \$220,000.00, a copy of which is on file with the City Clerk.




