

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTIONS OF RISK

PLEASE READ THIS FORM CAREFULLY and be aware that by registering for and participating in the 2016 CITY OF BLUE ISLAND CHRISTMAS LIGHT PARADE, sponsored by City of Blue Island Special Events (herein referred to as “City of Blue Island”) and in consideration, receipt which is acknowledged, of registering and/or participation of yourself and/or minor child/ward for the 2016 CITY OF BLUE ISLAND CHRISTMAS LIGHT PARADE, you will be waiving your rights and/or the rights of your minor child/ward to all claims for injuries you or your minor child/ward might sustain arising out of the 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE, and you agree to indemnify, hold harmless and defend 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE and its officials, employees, volunteers and agents for any and all claims arising out of participating in the 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE. I agree for myself and my heirs, distributors, guardians, legal representatives and assigns as follows:

RISK OF INJURY: As a participant and/or spectator in the 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE, or as a parent or legal guardian of a participant under 18 years of age, I recognize and acknowledge that there are certain risks of physical injury and agree to assume the full risk of injuries, including death, damages or losses which I or my minor child/ward may sustain as a result of participating in and/or as a spectator in the 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE sponsored by CITY OF BLUE ISLAND.

WAIVER OF CLAIMS: I agree to waive and relinquish any and all claims/demands, actions, causes of action and suits at law or in equity that I or my minor child/ward may have against CITY OF BLUE ISLAND and its officials, employees, volunteers and agents arising out of, connected with, or in any way associated with my or my child’s/ward’s participation of any of the activities associated with the 2016 CITY OF BLUE ISLAND CHIRSTMAS LIGHT PARADE.

RELEASE FROM LIABILITY: I do hereby fully release, remit and discharge CITY OF BLUE ISLAND and its officials, employees, volunteers and agents from any and all claims or actions for any injuries, including death, damages or losses which I or my minor child/ward may have or which may accrue on account of my or my child’s/ward’s participation.
