**ORDINANCE NO. 2017-001**

**AN ORDINANCE REQUIRING VEHICULAR TRAFFIC TO STOP AT A CERTAIN LOCATION WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK AND STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.  
(Greenwood and New Street)**

**BE IT ORDAINED** by the City Council of the City of Blue Island, County of Cook and State of Illinois:

**SECTION ONE**

For the purpose of this ordinance an intersection is defined as that portion of said streets lying within the prolongation of the lateral curb lines of each.

**SECTION TWO**

The operator of any vehicle proceeding on the street and in the direction hereinafter designated, said street being within the City of Blue Island, shall stop such vehicle at the stop signs hereinafter provided for before proceeding, except when directed to proceed by a police officer or as otherwise provided by law:

- (a) Northbound on Greenwood Avenue at its intersection with New Street.
- (b) Southbound on Greenwood Avenue at its intersection with New Street.

**SECTION THREE**

Appropriate traffic signs shall be erected by the Superintendent of Public Works on the northeast and southwest corners of Greenwood Avenue at or near the intersection of Greenwood Avenue and New Street, informing the public that vehicular traffic traveling in the aforesaid directions must stop before said intersection.

#### **SECTION FOUR**

The operator of any vehicle violating or failing to comply with any provisions of this ordinance shall be fined not less than Twenty-five Dollars (\$25.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

#### **SECTION FIVE**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


#### **SECTION SIX**




