ORDINANCE NO. 2017-002

**AN ORDINANCE REGULATING THE PARKING OF MOTOR
VEHICLES IN THE CITY OF BLUE ISLAND AT THE PROPERTY LOCATED AT
12610 GREENWOOD AVENUE, BLUE ISLAND, ILLINOIS**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

All previously existing time-related parking restrictions on the west side of Greenwood Avenue in front of the residence located at 12610 Greenwood Avenue are hereby repealed and rescinded, except that the snow route restrictions shall remain in full force and effect. Nothing herein shall be construed to rescind or amend the snow route restrictions at the designated area/s.

There shall be made one parking space consisting of fifteen feet (15 feet) which shall be designated as a "Handicap Loading Zone" In such loading zone, a vehicle may be left standing for up to one hour provided that the vehicle's hazard lights remain flashing and that the vehicle is being actively loaded or unloaded, and only by the individual, or individual's agent, displaying a handicap placard with registration number CG67841.

The loading zone restriction shall be in effect seven days a week from the hours of 7:00 a.m. until 7:00 p.m. After 7:00 p.m., parking restrictions set forth herein shall not apply.

SECTION TWO

The Superintendent of Public Works shall erect appropriate signs informing the public that the specified portion of Greenwood Avenue designated above constitutes a "Handicap Loading Zone" and specifying the time restrictions and placard registration as set forth herein.

SECTION THREE

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction be fined not less than Two Hundred Dollars (\$200.00) for each offense. The vehicle of any operator violating the parking restrictions herein shall be subject to immediate tow by the police.

SECTION FOUR

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION FIVE




