A RESOLUTION APPROVING THE CAPITAL IMPROVEMENT/ DEMOLITION AND ECONOMIC DEVELOPMENT PROJECT APPLICATION FOR FUNDING FROM THE COOK COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the Mayor and City Council of the City of Blue Island have heretofore established a continuing Community Development Program to promote the welfare of the City of Blue Island; and

WHEREAS, it is the policy of the City of Blue Island that existing vehicular traffic be maintained and, where necessary, be rehabilitated to enhance the value of all properties and means of ingress and egress within the City of Blue Island; and

WHEREAS, in furtherance of said policy the Mayor and City Council of the City of Blue Island deem it appropriate to apply for funding from the Cook County Community Development Block Grant Program for the 2017 Program Year for the purpose of improving the quality of life for the residents of the City of Blue Island; and

WHEREAS, an application is required by the County and is attached hereto and entitled "2017 Program Year Capital Improvement/Demolition and Economic Development Project Application."

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Blue Island, County of Cook and State of Illinois as follows:

SECTION 1

That a Request is hereby made to the County of Cook, Illinois for Community Development Block Grant ("CDBG") funds for Program Year 2017 in the amount of \$400,000 for the following project:

Project: Longwood Avenue Complete Street Resurfacing Amount: \$400,000

as identified in the City of Blue Island's CDBG 2017 Program Year application.


SECTION 2




