**INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF POSEN
AND THE CITY OF BLUE ISLAND RELATING TO THE EXCHANGE OF
MUNICIPAL PROPERTY AND MUNICIPAL SERVICES**

This Agreement entered into by and between the Village of Posen ("Posen") and the City of Blue Island, ("Blue Island"), and provides as follows:

WHEREAS, Posen and Blue Island are municipalities duly organized under the law of the State of Illinois; and

WHEREAS, Posen and Blue Island are neighboring communities that cooperate for the benefit of their residents and citizens; and

WHEREAS, Article VII, Section 10 of the 1970 Illinois Constitution and 5 ILCS 220/1 through 220/9 provide authority for intergovernmental cooperation; and

WHEREAS, Posen and Blue Island both deem it in their best interest to enter into an intergovernmental agreement wherein Posen will transfer ownership of its 2004 Ford-E 450 McCoy Miller Ambulance, VIN# 1FDXE45P94HB15969, to Blue Island and in exchange Blue Island will provide street cleaning service to Posen on one date in September, 2019 and one date in September, 2020.

NOW, THEREFORE, in consideration of the foregoing, and the mutual promises and covenants contained herein, Posen and Blue Island agree as follows:

1. Blue Island agrees to provide manpower and its street sweeping and cleaning equipment to Posen on one date in September, 2019 and one date in September, 2020, to clean the streets in Posen. The dates for the street cleaning in 2019 and 2020 can be changed by mutual agreement between the parties.

2. Posen agrees to provide Blue Island with an appropriate map of its streets and a tentative schedule for the street cleaning operation. Posen will also be responsible to

notify its residents of the date of operation and post appropriate notices in the Village informing the residents of the dates of the street cleaning operation in 2019 and 2020.

3. If necessary, Posen will provide a facility at its cost for the disposition of the refuse from its streets picked up during the street cleaning operation.

4 Posen agrees to transfer title and ownership of its 2004 Ford-E 450 McCoy Miller Ambulance VIN# 1FDXE45P94HB15969, to Blue Island upon execution of this Agreement.

5. This Agreement shall be in full force and effect for a term not to exceed two (2) years from the date hereof and shall terminate after Blue Island completes the street cleaning of Posen's streets in September, 2020. If necessary, the Mayor of Blue Island and Village President of Posen, or their designees, shall meet to discuss appropriate changes, if any, in the dates for the street cleaning to be completed and the details of how the street cleaning operation will be conducted.

6. The parties agree to cooperate fully with one another to implement and effectuate all of the terms of this Agreement.

7. All notices given pursuant to any provision of this Agreement shall be in writing and served by personal service or by certified mail, return receipt requested, on the parties at the following addresses:

For purposes of determining the date on which notice is given, notice by certified mail shall be deemed given on the date it is mailed.

8 This Agreement shall supersede any prior agreements between the parties relative to the subject matter hereof, with any such prior agreements being hereby repealed.
