ORDINANCE NO. 2019-022

**AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL
PROPERTY OWNED BY THE CITY OF BLUE ISLAND, ILLINOIS**

WHEREAS, in the opinion of the corporate authorities of the City of Blue Island, it is no longer necessary or useful to or for the best interest of the City of Blue Island to retain ownership of the personal property hereinafter described, and;

WHEREAS, it has been determined by the Mayor and City Council of the City of Blue Island to sell or dispose of said property because said property is no longer in operable condition.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BLUE ISLAND AS FOLLOWS:

SECTION ONE

Pursuant to Section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4 (2008), the Mayor and City Council of the City of Blue Island find that the following personal property described in Exhibit "A" attached hereto and now owned by the City of Blue Island is no longer necessary or useful to the City of Blue Island, and the best interest of the City of Blue Island will be served by its sale, salvage or disposal as junk.

SECTION TWO

The Mayor and City Council hereby authorize the appropriate City official to dispose of the personal property described herein by sale, salvage or disposition as junk, without the requirement of advertisement for bids, for such amounts or in such manner as may be deemed reasonable.

SECTION THREE

The Mayor and City Clerk are hereby authorized to execute all documents and perform all acts necessary to complete the sale and transfer of title to the personal property when required to do so.

SECTION FOUR


This ordinance shall be in full force and effect from after its passage by vote of the corporate authorities and approval in the manner provided by law.






