**ORDINANCE NO. 2019-023**

**AN ORDINANCE PROHIBITING PARKING ON PORTIONS OF HIGHLAND AVENUE  
WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS  
AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF**

**BE IT ORDAINED** by the City Council of the City of Blue Island, County of Cook  
and State of Illinois, as follows:

**SECTION ONE**

The word "park" shall mean the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading or unloading of merchandise, property or passengers, and except when necessary to avoid conflict with other traffic, or in compliance with the directions of a police officer or traffic control signal or device.

**SECTION TWO**

There shall be no parking on the street designated in Section Three.

The no parking restrictions set forth in this ordinance shall only be in effect on school days when school is in session between the hours of 7:00 a.m. to 8:00 a.m. and 2:00 p.m. to 3:00 p.m.

**SECTION THREE**

Those portions of the following street located within the City of Blue Island as hereinafter defined, for which there will be no parking as set forth in Section Two are:

- a) The west side of Highland Avenue between its intersection with Union Street on the North and its intersection with York Street on the South.

#### **SECTION FOUR**

Appropriate signs shall be erected on the street hereinabove set forth, informing the public that parking thereon is restricted or permitted as hereinabove provided.

#### **SECTION FIVE**

The owner of any vehicle violating or failing to comply with the provisions of this ordinance as they pertain to and concern restrictions on parking shall, upon conviction, be fined no more than Two Hundred Fifty Dollars (\$250.00) for each offense, or otherwise fined in accordance with the fee schedule as adopted or amended by the City of Blue Island. If the fines set forth herein are less than those established by the fee schedule or as ordered by a duly authorized hearing officer, the fines set forth herein shall be superseded.

#### **SECTION SIX**

If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

#### **SECTION SEVEN**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


#### **SECTION EIGHT**






