**AN ORDINANCE RESCINDING HANDICAPPED PARKING  
RESTRICTIONS AT 12824 LINCOLN STREET AND  
12753 SACRAMENTO AVENUE IN THE CITY OF BLUE ISLAND,  
COUNTY OF COOK AND STATE OF ILLINOIS**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

**SECTION ONE:**

The parking restrictions providing for handicapped parking only in front of the properties commonly known as 12824 Lincoln Street and 12753 Sacramento Avenue, City of Blue Island, are hereby repealed and rescinded.

**SECTION TWO:**

The Superintendent of Public Works shall remove all signs restricting parking on the portions of the street identified in Section One.

**SECTION THREE:**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


**SECTION FOUR:**






