**ORDINANCE NO. 2019-038**

**AN ORDINANCE ESTABLISHING RESIDENTIAL PERMIT  
PARKING OF MOTOR VEHICLES ON OLIVE STREET  
BETWEEN ITS INTERSECTION WITH VINCENNES AVENUE  
ON THE EAST AND ITS WESTERN TERMINUS IN THE CITY  
OF BLUE ISLAND AND PROVIDING PENALTIES FOR THE  
VIOLATION THEREOF**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois as follows:

**SECTION ONE**

The word “park” shall mean the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading or unloading of merchandise, property or passengers, and except when necessary to avoid conflict with other traffic, or in compliance with the directions of a police officer or traffic control signal or device.

**SECTION TWO**

Residential Permit Parking: It shall be unlawful for the operator of a vehicle to park said vehicle on that portion of the following street, within the City of Blue Island, as hereinafter designated as any portion of Olive Street between its intersection with Vincennes Avenue on the east and its western terminus without displaying a “Residential Parking Permit” or a “Temporary Visitor Parking Permit. The “Residential Parking Permit” must be fully and completely affixed to the lower front passenger side of the windshield. Partially removed or partially affixed permits will result in a citation for violation of this Ordinance. The “Temporary Visitor Parking Permit” must have all requested information completed and be displayed in the lower front passenger side of the windshield.

### **SECTION THREE**

Appropriate signs shall be erected by the Superintendent of Public Works informing the public that parking thereon is prohibited as provided in this ordinance.

The City Clerk shall be responsible for accepting, processing and issuing Residential Parking Permits and Temporary Visitor Permits and verifying the applicant's compliance with licensing, certification and registration requirements and the fact that the applicant has no outstanding City parking citations attributable to the applicant or applicant's vehicle prior to issuance.

### **SECTION FOUR**

The owner of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction thereof be fined not less than Fifty Dollars (\$50.00) nor more than Two Hundred and Fifty Dollars (\$250.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

### **SECTION FIVE**

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as corporate authorities.


### **SECTION SIX**




