ORDINANCE NO. 2019-046

AN ORDINANCE PROHIBITING PARKING OF MOTOR VEHICLES ON THE WEST SIDE OF CHATHAM AVENUE BETWEEN ITS INTERSECTION WITH VERMONT STREET ON THE NORTH AND FULTON STREET ON THE SOUTH IN THE CITY OF BLUE ISLAND AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois as follows:

SECTION ONE

The word “park” shall mean the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading or unloading of merchandise, property or passengers, and except when necessary to avoid conflict with other traffic, or in compliance with the directions of a police officer or traffic control signal or device.

SECTION TWO

No Parking: It shall be unlawful for the operator of a vehicle to park said vehicle at any time on that portion of the following streets, within the City of Blue Island, as hereinafter designated as the west side of Chatham Street between its intersection with Vermont Street on the north and Fulton Street on the south.

SECTION THREE

Appropriate signs shall be erected by the Superintendent of Public Works informing the public that parking thereon is prohibited as provided in this ordinance.

SECTION FOUR

The owner of any vehicle violating or failing to comply with the provisions of this ordinance

shall upon conviction thereof be fined not less than Fifty Dollars (\$50.00) nor more than Two Hundred and Fifty Dollars (\$250.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

SECTION FIVE

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as corporate authorities.


SECTION SIX






