**AN ORDINANCE RESCINDING HANDICAPPED PARKING RESTRICTIONS  
AT 12814 GREENWOOD AVENUE IN THE CITY OF BLUE ISLAND,  
COUNTY OF COOK AND STATE OF ILLINOIS**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

**SECTION ONE:**

The parking restriction providing for handicapped parking only in front of the property commonly known as 12814 Greenwood Avenue, City of Blue Island, is hereby repealed and rescinded.

**SECTION TWO:**

The Superintendent of Public Works shall remove all signs restricting parking on this portion of the street identified in Section One.

**SECTION THREE:**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


**SECTION FOUR:**






