**AN ORDINANCE RESCINDING HANDICAPPED PARKING RESTRICTIONS
AT 2212 123RD PLACE IN THE CITY OF BLUE ISLAND,
COUNTY OF COOK AND STATE OF ILLINOIS**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE:

The parking restriction providing for handicapped parking only in front of the property commonly known as 2212 123rd Place, City of Blue Island, is hereby repealed and rescinded.

SECTION TWO:

The Superintendent of Public Works shall remove all signs restricting parking on this portion of the street identified in Section One.

SECTION THREE:

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION FOUR:






