# AN ORDINANCE RESTRICTING A PORTION OF A CERTAIN STREET FOR HANDICAPPED PARKING ONLY WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, it is the public policy of the State of Illinois, as enunciated in the State Constitution, that handicapped persons are entitled to enjoy the fruits of a full and meaningful life; and

WHEREAS, the Mayor and City Council of the City of Blue Island hereby declare that it is the public policy of the city to encourage and assist handicapped persons to participate fully in the social and economic life of our community; and

WHEREAS, to implement such policy the Mayor and City Council of the City of Blue Island recognize it is desirable to restrict certain portions of the public ways within the City of Blue Island for handicapped parking only;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

## **SECTION ONE**

That this portion of the street within the City of Blue Island, as hereinafter designated, is hereby restricted for handicapped parking only:

a) On the north side of New Street in front of the residence whose common address is 2450 New Street (one space consisting of a total of twenty (20') feet)

## **SECTION TWO**

Appropriate signs shall be erected by the Superintendent of Public Works on the portion of the street designated above informing the public that parking thereon is restricted or permitted as hereinabove provided for.

## **SECTION THREE**

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction be fined not less than Two Hundred Fifty Dollars (\$250.00) nor more than Three Hundred Fifty Dollars (\$350.00) for each offense.

## **SECTION FOUR**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

## **SECTION FIVE**

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as Corporate Authorities.

# AN ORDINANCE DESIGNATING RESIDENTIAL PERMIT PARKING ONLY DISTRICT B6 WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF

**BE IT ORDAINED** by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

### SECTION ONE

The word "park" shall mean the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading or unloading of merchandise, property or passengers, and except when necessary to avoid conflict with other traffic, or in compliance with the directions of a police officer or traffic control signal or device.

## **SECTION TWO**

Parking on those streets designated in Section Three is hereby restricted to those vehicles that properly display a "Residential Parking Permit," as described in Section Five or a "Temporary Individual Visitor Permit," as described in Section Six.

The parking restrictions set forth in this ordinance shall be in effect twenty-four (24) hours a day, Mondays through Sunday, inclusive. The parking restrictions shall also apply on Saturdays, Sundays and Legal Holidays.

## **SECTION THREE**

Those portions of the following described streets located within the City of Blue Island as hereinafter defined, are hereby incorporated into Residential Permit Parking Only District B6:

a) Beginning on the west side of Vincennes Avenue from its intersection with 122<sup>nd</sup> Street and then proceeding in a general northerly direction along the west side of Vincennes Avenue to its intersection of 119<sup>th</sup> Place and Vincennes Avenue; thence westerly along the north side of 119<sup>th</sup> Place to its intersection with Longwood Avenue; thence in a general southerly direction along the west side of Longwood Avenue to its intersection with 122<sup>nd</sup> Street, thence in a general easterly direction along the south side of 122<sup>nd</sup> Street to its intersection with Vincennes Avenue. Also on the north and south side of 122<sup>nd</sup> Street from Longwood Avenue to Irving Street.

## **SECTION FOUR**

Appropriate signs shall be erected on the street hereinabove set forth, informing the public that parking thereon is restricted or permitted as hereinabove provided.

#### **SECTION FIVE**

Upon receipt of an application and appropriate proof of actual residence within the Residential Permit Parking Only District B6, the City Clerk is hereby authorized to issue annual "Residential Parking Permit" decals to residents of the district whose principal place of residence is located in the district. The decals shall be for use on each vehicle owned and registered to the

resident living within Residential Permit Parking Only District B6, displaying a current city vehicle sticker and being free from any and all outstanding parking violations for violation of City of Blue Island Parking Ordinances. The decal shall be affixed, in accordance with the instructions printed thereon and without the use of supplemental adhesives, at the lower left hand corner of the inside of the glass portion of the windshield of such motor vehicle. This permit decal shall not guarantee or reserve any parking space nor shall it exempt the holder from the observance of any traffic or parking regulation.

## SECTION SIX

Ten (10) individual permits shall be issued to residents of the district for the use of non-residents who are temporary visitors of the resident permit district. A temporary visitor is defined to be a non-resident of the district who shall not park his vehicle in the district for a period in excess of twenty-four (24) hours. These permits shall be displayed on the left hand side of the dashboard and shall be made visible from outside the vehicle. The permit shall have the address of the resident, to which it was issued, displayed. A permit without the address printed legibly will be considered invalid. Additional visitor permits or permits allowing parking in the district to a non-resident of the district for a period in excess of twenty-four (24) hours may be acquired upon application and presentation of appropriate proof, to the City Clerk, establishing the need for these permits. These permits shall be valid for a limited period of time as stated on the face of the permit.

### **SECTION SEVEN**

The owner of any vehicle violating or failing to comply with the provisions of this ordinance as they pertain to and concern restrictions on parking shall, upon conviction, be fined

not less than Twenty-five Dollars (\$25.00) nor more than Two Hundred Fifty Dollars (\$250.00) for each offense.

## SECTION EIGHT

A replacement of an annual "Residential Parking Permit" decal will be issued without cost upon receipt of an identifiable portion of the removed decal and a receipt for the current city vehicle sticker. Replacement of any permits which are lost or destroyed will be made for a cost of \$10.00.

## **SECTION NINE**

The sale, transfer or other inappropriate use of permits and visitor's passes shall also be considered a violation of this ordinance. Any person who violates this section of the ordinance shall, upon conviction, be subject to a fine of Two Hundred Fifty Dollars (\$250.00) and revocation of residential permit parking privileges, established pursuant to this ordinance, for a period of thirty (30) days for a first offense and for a period of sixty (60) days for each subsequent offense.

## **SECTION TEN**

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

## **SECTION ELEVEN**

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as corporate authorities.

A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, REQUESTING THAT A PROPOSITION TO BECOME A HOME RULE UNIT BE SUBMITTED TO THE ELECTORS OF THE CITY OF BLUE ISLAND AT THE APRIL 9, 2013 CONSOLIDATED ELECTION

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the City is a non-home rule unit of government within the meaning of the Constitution of the State of Illinois (the "Constitution"); and

WHEREAS, the Constitution provides that a municipality that has a population of less than 25,000 may elect by referendum to become a home rule unit, and

WHEREAS, Article VII of the Constitution permits the governing body of a municipality of less than 25,000 in population to enact a resolution to submit by referendum to its electors the proposition of whether or not such municipality shall become a home rule unit; and

WHEREAS, the Mayor and the City Council of the City of Blue Island (the "Corporate Authorities") desire to submit to the electors for their consideration the proposition that the City of Blue Island become a home rule unit.

NOW, THEREFORE, be it resolved by the Mayor and Council of the City of Blue Island, Cook County, Illinois as follows:

SECTION 1: The following referendum question shall be placed on the April 9, 2013 Consolidated Election ballot in the City of Blue Island:

Shall the City of Blue Island become a home rule unit of government?	Yes

SECTION 2: The City Clerk is hereby authorized and directed to file a certified copy of this Resolution with the Cook County Clerk within the time authorized by law to certify a proposition to be submitted to the electors of the City at the April 9, 2013 Consolidated Election.

SECTION 3: The City Clerk is hereby further authorized and directed to file within forty-five (45) days after the referendum, if approved, a certified statement with the Illinois Secretary of State, showing the results of the referendum that determines the status of the City as a home rule unit.

SECTION 4: If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution.

SECTION 5: All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

SECTION 6: This Resolution shall be in full force and effect immediately upon its passage, approval and publication as provided by law in order to preserve the health, safety and welfare of the residents by ensuring that the electors of the City are afforded the opportunity to consider the public questions herein contained.

# COMMUNITY DEVELOPMENT COMMITTEE MINUTES OF THE DECEMBER 27, 2012 MEETING

The meeting was called to order at 6:35 p.m.

Present: Aldermen Vieyra, Potaska, Stone, Ostling, Johnson, Buckner & Thompson

Also present: Fire Chief Terry Vrshek, Building Commissioner Robert Adams, Planning Director Nick Crite, Ald. Frausto and City Attorney Terry Sullivan

Special Meeting for the Revocation of the Business License of the Island Sports Bar & Grill:

The Committee called a Special Meeting pursuant to Notice concerning the status of the Business License of Island Sports & Grill because of complaints that the current operation of the business endangers the health and safety of the community.

Alderman Frausto testified that he has received numerous complaints concerning the operation of the Island Sports & Grill located at 13414 South Olde Western Avenue, Blue Island, Illinois 60406. Alderman Frausto stated that some of the complaints include but not limited to: noise-music originating from the establishment that can be heard in the immediate neighborhood; patrons of the establishment parking in residential areas and many times parking illegally; bottles and other debris thrown in residential areas; public urination; public intoxication; patrons disturbing the neighborhood when leaving the establishment at closing.

Michael Sinde, 12718 Greenwood Avenue, Blue Island, Illinois 60406, testified that upon visiting the Maple Tree (located a block north of the establishment) he has notice empty bottles-cases of beer; vehicles proceeding the wrong way on Olde Western Avenue. Mr. Snide also submitted a letter from the Maple Tree concerning the present situation at the Island Sports Bar & Grill. Finally, Mr. Snide stated that the original business plan submitted by the license holder called for a family restaurant and not a club.

Dewey Smith, 4275 Thunderbolt, Scott Air Force Base, Illinois, testified that he is a police officer for the Village of Markham presently on leave for military duty. He stated that he and his wife patronize the business because it is a safe and enjoyable place. Further he stated that you must be 25 years of age or older to enter the premises.

Michael Evans, 10765 Warsaw, South Holland, Illinois, testified that he dj's on Wednesday playing Jazz. He stated that the patrons who come in on the day he dj's are in their 40's and 50's. Never had any trouble.

Adam Shorter III, 13414 Olde Western Avenue, Blue Island, Illinois 60406, the license holder appeared before the committee represented by his attorney, Randy Crampton, 70 West Madison Street, Suite 1400, Chicago, Illinois 60602. Mr. Shorter stated that he could not address the letter from Maple Tree because he has not had an opportunity to review it. Mr. Shorter did state that he has acquired an additional parking. He has entered into an arrangement with the Laundromat to utilize their parking lot. Mr. Shorter stated that he has hired additional security; placed signs within in his establishment requiring patrons to respect the neighborhood; strict with his last call prior to closing; strict rules prohibiting leaving the premises with any type of container; use of more trash containers outside the premises; strict with occupancy limits (security at the door with a counter); put in place a policy of escorting patrons to their vehicle; and will be more aggressive in patrolling outside the premises. Finally stated that he has a strict age limit of 25 years of age or older before being allowed admittance.

Alderman Johnson stated the Municipal Services Committee will be considering residential or permit parking for the area. Alderman Janko reiterated that his Committee will impose parking restrictions.

Apolonia Alvardo, 13434 Olde Western Avenue, Blue Island, Illinois 60406, testified to noise and general disruption to the neighborhood caused by the patrons because they loiter after closing.

Anele DeLavria, also testified to the negative affect the establishment has on the neighborhood. Even though her bedrooms are located at the rear of their residence her family's sleep is interrupted by the noise and unruly behavior when the patrons leave the Island Sports & Grill.

After much discussion between the committee members a Motion was duly made and second to give Mr. Shorter 90 days to institute the changes he represented to the committee. This Motion was defeated by a roll call vote of 4 nays and 3 ayes.

Thereafter a motion was made as follows: Reducing the hours of operation to 1:30 A.M., Monday through Sunday, inclusive pending review within 60 days to verify that Mr. Shorter's changes take place. This motion was second and upon a roll call vote of 4 ayes and 3 nays

was passed. This requirement was stayed pending an appeal to be heard by the entire City Council at its January 8, 2013 regularly scheduled meeting.

There being no further business, the meeting adjourned at 8:25 p.m.

To whom it may concern,

This letter is to address some concerns regarding "The Island" bar in Blue Island. Over the last several months there has been some disturbing behavior that has been occurring on Olde Western Avenue that has coincided with the opening of "The Island".

Since their opening, there has been a huge increase of vehicles traveling the wrong way down Olde Western, particularly after 9:00 pm. These vehicles have no regard for legal traffic or pedestrians and present a safety issue not only to the residents, but also to patrons of other businesses. On numerous occasions we have had to pick up empty six pack and case containers left in the Canal Street parking lot. There have been bottles strewn throughout the lot as well as empty bottles put back in the case and left outside vehicles on the asphalt. There have been numerous occasions of people drinking alcohol in their vehicles, while parked either on Olde Western Avenue or in the Canal Street Lot, with most occasions noticed by our customers walking in and telling our staff.

Most importantly, there seems to be a constant issue of traffic jams outside the entrance of "The Island". This is more than people dropping off and picking up. There is a willful neglect of traffic laws that seems to only happen during business hours of "The Island". Such examples include:

- 1. Cars will stop in the middle of the street for several minutes, while people enter and exit the vehicles while yelling at other patrons, blocking both lanes of traffic.
- 2. Cars will stop in the southbound lane and just sit there for several minutes (or 15) and wait for a parking spot to open up.
- 3. When leaving their designated lot, cars will pull into Olde Western Avenue and block traffic (both lanes) to stop and talk to other patrons and/or the bouncer at the door.
- 4. On several occasions, as we have been driving southbound, we have been cut off and almost been hit by cars leaving the designated parking lot of "The Island" where the drivers are visibly distracted (eg: talking on cell phones while driving, yelling at other patrons while leaving, talking to another car blocking traffic).

It seems as though the patrons of "The Island" do not respect the business itself, let alone the neighbors, businesses and city. I would ask that some measures be put in place to curb these behaviors before something more serious occurs.

Mr. Shorter requests a hearing before your honor and the entire city council, pursuant to Section 7 of city of Blue Island's Ordinance number 86-58, regulating commercial businesses.

Mr. Shorter has made significant progress to clear up some of the issues which has required him to increase his operation costs, including hiring additional staff, acquiring additional parking space and purchasing materials. Even though the Committee was informed of the progress Mr. Shorter has made in a week's time, although the negotiation for the some of the additional parking space took much longer, the Committee refused to allow time to see how his efforts will work. Instead, they voted to shorten his hours of operation which will have a negative effect on his income as he has just increased his operation costs.

Further, we do not believe that procedurally the revocation hearing was proper or warranted at this time. Thus, we appeal and request a hearing before your honor and the entire city council.

As you are aware, I represent Mr. Adam Shorter and Island Sports Bar and Grill. On Thursday, December 27, 2012, the Community Development Committee voted to shorten the hours of operation of Island Sports Bar and Grill. Needless to say, Mr. Shorter was disappointed with the vote because of all the corrective and cooperative measures he had taken to work with the community, with many of those actions being proactive. These measurements increased his operation costs and by shortening the business hours of the bar, Mr. Shorter's income will be negatively affected. Therefore, Mr. Shorter feels his business is being punished for growth.

Island Sports Bar and Grill is a full-fledged restaurant and a bar. SEE ATTACHED MENU. It has never strayed from the original business plan. Island Sports Bar and Grill is listed on restaurant.com and has sold coupons on Groupon.com, in addition to serving walk-in customers daily. Mr. Shorter wants to ensure you and the City Council that he is doing everything he can to be cooperative with the city and remedy any concerns in regards to complaints stemming from his busiest nights.

Some of the corrective measures Mr. Shorter has taken include the following:

a) Island Sports Bar and Grill has always held a no smoking policy within 20 feet of the entrance door. Now, two cigarette receptables have been placed in a designated smoking area. SEE ATTACHED PHOTOS.

- b) Additional trash cans have been placed outside. SEE ATTACHED PHOTOS.
- c) Mr. Shorter has hired additional security staff to work during heavy traffic hours.
- d) Mr. Shorter has hired additional staff to make sure the external area of the bar is cleaned during and after heavy traffic.
- e) He has obtained additional parking lots for parking, including use of the laundry parking lot that he had just acquired the week of the December 27, 2013 meeting. SEE ATTACHED COPY OF INSURANCE ENDORSEMENT FOR THE LOT. In addition, Mr. Shorter is adding more signs to indicate to his patrons where to park.
- f) Mr. Shorter now announces the closing of the bar earlier so people will be begin to leave earlier instead of all at once.
- g) During hours of operation, Mr. Shorter will have it announced that patrons cannot park in the community.
- h) Mr. Shorter has worked with local alderman to discuss remedies, including but not limited to residential parking restrictions.

To date, there have not been any incidents at Island Sports Bar and Grill. Mr. Shorter has not received any citations or tickets. Since opening day, Mr. Shorter's trained security team has been in place to ensure the safety of Island patrons and its surrounding neighbors. Mr. Shorter is willing and able to talk to anyone who is willing to share their ideas and suggestions with regards to helping to make Sports Bar and Grill remains a successful business in Blue Island.

Pursuant to language in the city's Ordinance Number 86-58, a business should get three notices of a violation of the Ordinance and a time frame to correct the problem each time before there is a revocation hearing. That is not what happened in this case.

Mr. Shorter respectfully requests that the City Council vote to reject the recommendation of the Community Development Committee to shorten his business hours.







## REPORT OF CITY OFFICIALS

#### **Mayor**

Mayor Peloquin announced that Council should have a copy of the letter that Attorney Brosnahan had submitted to his office. Mayor Peloquin stated that it has been enjoyable working with him and thanked him for all of his services. The Mayor stated that Attorney Brosnahan would be pursuing other things starting the first of the year. The Mayor wished him well and let him know that the Island's will always be home where he could come back to.

Ald. Rita arrived to the meeting (7:05).

Attorney Brosnahan thanked the Mayor, City Council, Pam Frasor and everybody here in giving him the opportunity for being the City's Attorney for the last 3-years. It has been a wonderful experience and worked with some tremendous people.

Mayor Peloquin is requesting approval of his appointment of the Law Firm Odelson & Sterk to be our legal council with Felicia Frazier being our representative here.

On the Question: Ald. Johnson asked if they would be in the same salary range.

The Mayor stated no, they would be working for an hourly rate.

There being Twelve (12) Affirmative Votes, the Mayor declared the motion carried.

Mayor Peloquin welcomed Felicia Frazier.

Mr. Burt Odelson introduced and gave a little history of himself and stated it was an honor to step up in this position and to work with everyone.

Mayor Peloquin wished Mr. Odelson a Happy Birthday and presented him with a Birthday cake.

Ms. Felicia Frazier stated it was an honor and thanked everyone for the opportunity.

Mayor Peloquin stated that Council should have a copy of a litigation settlement agreement. The Mayor is working with CSX and Tom Livingston will be going down to Springfield to try to

help us pass some legislation to try to get some of the whistle blowing to stop. We will continue to work on this.

Mayor Peloquin stated that he has received phone calls from the Aldermen in regards to the 2 referendums on the agenda. The one regarding the Home Rule and the Mayor was asked why he would he put this on. (1) Is the fact that they are allowed to put 3 issues on the referendum and in talking to Mike Anastasia, our financial situation will always be tenuous, never having enough cash access. The State still owes us about \$400,000 and it's an on going process. The Mayor stated in the course of the next year he will not be here but would like to give what ever administration that did come in an opportunity to address these issues in whatever manner they see fit and you can not do that unless you have Home Rule. The Mayor had asked to have a gas tax put on as a referendum but the Attorney's advised us that we couldn't.

(2) The City is in a situation that the revenue has been flat and within the next 2 years health issue will be a factor. The Mayor stated the issue regarding Home Rule if Council wants to do it that's fine and if you don't want to do it that's fine too. This would be the only time for it to be put on the ballot for the April 9<sup>th</sup> election.

Mayor Peloquin announced to Council that they should have a map, which is the site of the commuter parking lot along the Cal Sag, and the Developers are requesting approval to begin the process to come out and begin the pubic hearings and to address Council to get their input.

The Mayor is requesting permission from Council to continue to meet with them and bring this forward so the process could begin with having public hearings in regards to this whole idea.

On the Question: Ald. Janko asked if the City owns this property.

The Mayor stated no, it's Water Reclamation District property.

Ald. Janko asked how would it affect the use of it.

The Mayor stated right now it's a parking lot and our goal is to go to Water Reclamation and have them be a part of it.

Ald. Johnson asked if the Development Company doing this would be using realtors.

The Mayor stated no, this will all be done in house.

Ald. Janko asked if there was any cost to the City for them coming out.

The Mayor stated no.

Ald. Johnson asked that this is coming to question for them to come to us with information.

The Mayor stated this is to start the process forward.

Ald. Vargas asked if there would be public forums regarding this.

The Mayor stated yes.

Mr. Sullivan informed the Committee that the majority of cases were Worker's Comp cases and Medical Claims.

Mr. Sullivan informed the Committee that he attended an Insurance Seminar regarding the new health care law; there will be a lot of changes. It will be necessary to inform the City Employees of the up coming changes, shifting from one plan to another. The policy is from July to June and will be changed to January 1<sup>st</sup> to December 31<sup>st</sup>.

It will be law mandated to list on employee W-2 form their health benefits. Contraception and women reproduction will be an issue.

Starting January 1, 2014 the cost of health care needs to be shown on employee's W-2 forms.

Health Care needs to be offered starting January 1, 2014 for any City Employee working on average 30 hours per week. An Employee can waive benefits.

Drug and alcohol testing was discussed. A reasonable suspicion such as an accident will be cause for testing. Random drug testing is occurring at the present time, 2 per month.

Ald. Janko brought up the issue of a handicapped parking spot.

Mr. Stevo asked about the status of the JAWA referendum.

According to City Attorney Sullivan it is being worked on and needs to be completed prior to January 7, 2013.

Mr. Stevo asked how many lawsuits are pending against the City.

Superintendent of Public Works Ken Stachulak reported on leaf pickup – final citywide parkway pickups were completed the week of 12/3. If residents have yard waste materials they are asked to place them in an appropriate yard waste container and place them in the alley.

Public Works is preparing the fleet for snow removal. Truck #105 has had the dump body repaired and truck #118 is getting new dump body.

Public Works has had he HVAC system at the Wireton Road garage replaced through a grant they received.

Christmas Light Parade, Public Works participated with two of its vehicles a great time was had by all.

Superintendent of Water Joe Werner reported on several projects the department is working on. They have replaced the RPZ at the Rec Center splash pad and it should be functional next summer. The Superintendent recently conducted inspections at the Mother of Sorrows facility related to the large dining hall and water closets. He identified what needs to be done to bring these areas up to code so that the space could be usable.

The master meter at the Vincennes Pumping station went down and is being replaced no interruption to water service occurred.

The sewer lines between the 4 catch basins and 1 catch basin itself at 123<sup>rd</sup> and Maple are being repaired. During an inspection a break in the sewer line was discovered and repairs have been scheduled.

Facility improvements to lighting were made at the Highland Station and Garage. The lighting improvements were paid for through a DECA grant the city received.

Director of Golf Operations Jerry Vidovic reported the Golf Course income for the month of November amounted to \$42,861.30; this is on par with the past Novembers.

Projects the Golf Course Club House is scheduled to be resided (\$7,100.00 Lowest Bid) the pond on hole 13 is in need of cleaning it has filled with silt and debris over the years (approximately \$8,000.00) and is scheduled weather permitting. The tall grass and cattails were cut down on the 11<sup>th</sup> hole this was much needed and provides open view for the residents of Fairway Meadows.

Jerry also reported that 2008 cart lease is up and the meadows will be getting 25 new carts for the 2013 season.

The Committee also discussed the contract with Service Scape, which is ending and asked Jerry to negotiate 1-year term with the company. He will be checking into it and will report back at the January meeting.

Ald. Ruthenberg discussed parking problems on Edison Street (2900 Block) a resident notified him that students from

Eisenhower High School has been parking on the street causing an inconvenience for residents of the block. The Committee will look into this further.

Ald. Janko discussed the possibility of having a "conservation water rate" for single-family households. This would be a rate set below the current minimum usage charged by the City. The Committee and Superintendent Werner agreed that much research would be needed to see what that rate would be and if it would be feasible. The committee will look into this and report back to the Council.
