ORDINANCE NO. _____

**AN ORDINANCE PROHIBITING PARKING UPON A
PORTION OF A CERTAIN STREET WITHIN
THE CITY OF BLUE ISLAND, COUNTY OF COOK,
STATE OF ILLINOIS, AND PROVIDING PENALTIES
FOR THE VIOLATION THEREOF**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

The word "park" shall mean the standing of a vehicle, whether occupied or not, otherwise than when temporarily and actually engaged in loading or unloading of merchandise, property or passengers, and except when necessary to avoid conflict with other traffic, or in compliance with the directions of a police officer or traffic control signal or device.

SECTION TWO

It shall be unlawful for the operator of any vehicle to park said vehicle on that portion of the following street, within the City of Blue Island, as hereinafter designated:

On the north side of Oak Street from the point on the east where it intersects with Division Street to a point on the west where it intersects with Hoyne Avenue.

SECTION THREE

Appropriate signs shall be erected by the Superintendent of Public Works informing the public that parking thereon is prohibited as hereinabove provided.

SECTION FOUR

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction thereof be fined not less than Fifty Dollars (\$50.00) nor more

than Two Hundred Fifty Dollars (\$250.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

SECTION FIVE

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION SIX

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as corporate authorities.

JOURNAL OF PROCEEDING

Ald. Janko stated a correction in the last Municipal Service Report minutes it was reported that there were 300 tires cleaned up and the count should have been more than 3000 tires cleaned up on page 8.

HONOR PRESENTATION

Mayor Peloquin invited Chief Vrshek to join him at the podium for a presentation to honor one of their finest Firefighters.

Lieutenant Jim Klinker approached the podium and was awarded a Certificate of Recognition on receiving his Bachelor Degree on Fire Science.

Lieutenant Klinker thanked everyone for their support.

BRIDGE DRAFT

Mayor Peloquin announced every one should have a copy of the rough draft of the bridge. There are 2 more phases before the final draft will be complete. A decision would have to apply for either a rebuild or a total reconstruct. The Mayor's recommendation to Council, even though he will not be there, is for a reconstruct. It would cost about 9 million dollars and the Mayor recommends that Council begin the process now to have the Engineer draw up the plan to set this all in motion.

Ald. Janko asked on the design if the bridge would be a truss type or a girder beam type bridge.

Mayor Peloquin request the City's Engineer, Tom Nagel come up to answer any questions.

Mr. Nagel stated as far as the reconstruct, they would be removing the existing bridge and the 2 options are to have a girder or have an arch. They cannot go with the same structure that is there now. Mr. Nagel is sure that it will be an arch.

Ald. Janko asked if typically the girder style is more economical to maintain.

Mr. Nagel stated it is but the reason is the depth and the arch of the bridge that would be put in, any other system would be much to complicated. Mr. Nagel feels this would be a landmark for the area.

Ald. Johnson asked if this is guaranteed for 100 years.

Mr. Nagel stated no it is not. The Federal Highway Authority mandates that you do a net present value on both options over a 100-year period. That is the estimated life of a bridge with normal maintenance.

Ald. Patoska asked how long would the construction take.

Mr. Nagel stated from the start of construction roughly a year and a half to maybe two years.

PARKING LOT LEASE

Mayor Peloquin requested to change the lease on the parking lot east of Chatham in regards to begin the process with the Community Builders with the stipulation if the process does not move forward, the City does not lose the lease and maintain the lease with Water Reclamation.

Fire Department Report –

The Fire Department had 274 emergency calls in January, 177 were EMS.

59 medical, 15 psychiatric evaluations, 24 injuries, 13 cardiac, 29 breathing, 2 diabetic responses, 9 vehicle accidents, 1 overdose 5 seizure calls 5 DOA, 23 patients refused transport,

2 accidental medical alert, 7 lift assists no transport and 3 battery victims.

159 patients treated
138 patients transported

Fire Department responded to 16 fire alarms, which were assisted by other towns –
2 pull box activated by children, 3 leaking water into detectors, 2 dust created while working, 3 phone lines, 3 faults with detectors, 1 smoke odor and 2 cooking.

Four structure fires –
3 from unattended cooking and 1 bedroom fire.

5 calls were for carbon monoxide alarms.

We responded 23 times to assist other towns
We received aid from other towns 21 times
We had 30 man to station calls.

We have not heard from FEMA regarding grants applied for.
We have contacted Senator Durbin, Senator Kirk and Representative Rush for support. Kirks office responded that he did send a letter of support for our grant.

One Firefighter will be off for 1 year with injured shoulder and has applied for disability pension.
One Firefighter is expected to return in April after knee surgery
One full time Firefighter was hired
One part time Firefighter was hired.

The Fire Prevention Officer position has been filled however the Committee will hold a special meeting to hear a grievance filed by the Union in regards to this position.

Medical reimbursement service for January is \$24,078.40
Processing fee is \$2,287.45.

Ambulance 2152 was sent out for repair for a fuel leak is back in service.

Police Department Report –

430 parking tickets issued, 289 moving violations issued, 17,361 miles patrolled, 5,777 number of computer aided dispatch (cad calls), 1 search warrant, and 2 major crime task force call out.
