**AN ORDINANCE APPOINTING REPRESENTATIVES TO THE
SOUTH SUBURBAN JOINT ACTION WATER AGENCY**

WHEREAS, on November 22, 2011, the City Council of the City of Blue Island approved an Intergovernmental Agreement to establish the South Suburban Joint Action Water Agency; and

WHEREAS, Section 3.1 of the Intergovernmental Agreement requires each member to appoint a Director and an Alternate Director to serve on the governing board of the South Suburban Joint Action Water Agency; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Blue Island, Cook County, Illinois.

SECTION ONE

That Carmine Bilotto, Treasurer of the City of Blue Island shall be appointed Director and Michael Janko, Mayor Pro-Tem and Alderman of the 5th Ward of the City of Blue Island shall be appointed Alternate Director to the governing body of the South Suburban Joint Water Agency representing the City of Blue Island.

SECTION TWO

This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Ald. Stone approached the podium and stated on behalf of the Alder-Chick's thanked the Mayor for 28 great years to the great City of Blue Island and he will be missed. She then presented him with a gift.

Mayor Peloquin stated there is a tradition when people leave the City Council they are presented with a plaque and it is his honor as Mayor to present them.

Mayor Peloquin presented Ald. Natalino with a plaque honoring and thanking him for serving the 1st Ward.

Mayor Peloquin presented Ald. Spizzirri with a plaque honoring and thanking her for serving the 2nd Ward.

Mayor Peloquin presented Marcia Rauch, mother of Ald. Patoska with a plaque honoring and thanking him for serving the 3rd Ward.

Mayor Peloquin presented Ald. Ruthenberg with a plaque honoring and thanking him for serving the 4th Ward and for being a good friend for over 50 years.

Mayor Peloquin stated that this all happened across the street in Krueger Funeral Home parking lot with Andy Botte, Pam and himself talking in the rain about what they thought would be good for Blue Island. They began a career working together and bringing people in and Pam was instrumental in that.

Mayor Peloquin presented City Clerk Pam Frasor with a plaque honoring and thanking her for many years of service and dedication to the City.

Mayor Peloquin is requesting permission from Council to go sine die for all the Committees and its structures.

Mayor Peloquin is requesting permission from Council to appoint Ald. Janko as Mayor Pro-tem so he can conduct the meeting in May for the swearing in of new Mayor and Alderman.

There being Twelve (12) Affirmative Votes, the Mayor declared the motion carried.

Mayor Peloquin announced at the next meeting Mayor Pro-tem Janko will call the meeting to order, Deputy Clerk Linda will enter the roll call; then the certification from County with the election results will be voted in and then there will be a swearing in ceremony. The Mayor stated that's what he thought would occur but he would not be there.

Mayor Peloquin stated he could not tell the people of Blue Island how much he appreciated the opportunity to have served as Mayor of so many years. The Mayor stated he used to have dark hair when he started, now he doesn't.

He gave a personal thank you for the people who have been with him for a long, long time. He had mentioned Pam Frasor earlier who has been with him; Carey Horvath as the Attorney, the people of Blue Island will never realize how much he has done for the City and how much he saved the City in the fact that he did the job for what he did it for and that was all over a bowl of chili at Cliff's. He brought on Mike Anastasia to do the TIF's then it went from one thing to another to another, he did all kinds of jobs. The Mayor thanked Mike for his dedication to the City.

The Mayor thanked City Attorney Terry Sullivan who is like family to him. It goes beyond what we do in the office, it is a great relationship and he is proud to say he is his friend and he has been a great advocate for the City.

Mayor Peloquin went on to say how they had built a Golf Course on a land fill and thanked Jerry Vidovic and the Vidovic Family because for the first 5 or 6 years when we could not get people to play he brought people to the Golf Course. The Golf Course will now finish its 20th year and next year the bond issue to the Golf Course will be paid off. With the homes that have been built and for what it has done the Golf Course is something that we have dreamt about, we initiated it and a lot of people didn't think it would happen. Dickie Decker and Roger told him point blank that he would never build a Golf Course on a land fill then he was the first one to buy a golf cart and drive over there and thanked Jerry Vidovic again for all he has done.

Mayor Peloquin thanked the Hickey Family for allowing him to do this; his partners for allowing him to do this; his family and kids. He went on to say you can never understand how important it is to have a wife support you and be your best friend and he has the best.

Mayor Peloquin spoke of the accomplishments they have done. When he talks about the Union contracts when they came into the

City there was no health insurance, no liability insurance, first for union contracts, this building was purchased they had no funding for it and they built things from that. They never looked back – they always looked forward and always looked to the positive and they always tried to find ways to make things happen for the betterment of Blue Island.

When you look at all the things that they have accomplished –

- They fought and got 41 additional parking spaces on Western Avenue with IDOT.
- They developed probably 200 plus tax delinquent pieces of land that now have businesses or homes on it.
- They developed areas in the City in the idea of what could be the future here for economic growth.
- The projects on the Cal Sag.
- Worked with all kinds of State, County and Federal Officials.
- The purchase of the VFW hall.
- A 911 Center that dispatches for a number of towns.

You've taken it past the point of what Blue Island is to a regional approach, you've taken it to the point where we are now looking to help develop jobs everywhere with in that area.

When you talk about the streets and infrastructures, Tom Nagel with Robinson Engineering has been with the City from before he became Mayor. One of his strongest advocates was Don DiSantis early on. We are at the point now where 45% of the streets and sewers are finished and there is an opportunity coming with the Golf Course bond being done to look at finishing the City's sewer and street repairs and water in a very short period of time. It's all right there for everyone.

Mayor Peloquin can't thank enough the staff employees in every department. The City of Blue Island has some great people working for it. They don't work for a lot of money but they do their best and they do everything they can to make this City a better place. He has been the benefit of that as Mayor and the City has been the benefit of that as it has worked out.

You won't find many towns that would pick-up in front of your house like we do here.

The California Gardens – when we started that, a day like today with all the rain you would be rowing down in boats. We finished that by putting streets and sewers in.

Some of Mayor Peloquin's proudest moments are when they elected the first Spanish Alderman, Carly Jackson was the first African American elected Alderman and you couldn't have found a better man and a better individual to do that. The Mayor thanked Carly.

Mayor Peloquin stated you have the opportunity in the future if you all work together. The business community has been great for him with Elaine Lentz running the Chamber and they would bump heads all the time, Main Street with Fran Blouin and the programs for the businesses. They have always tried programs and worked with the people and that is what you're going to have in the future.

The Park District and the City has begun a program to develop the river front from Kedzie to Ashland. You will be able to get the 94 slips at Fay's Point which will allow the City to control the Marina and do the rowing events that we did for a short period. This could be the catalyst to bring in thousands of people on the weekend and to make this a national center for rowing. It could be the catalyst for all other economic growth tying into the hospital and what they are planning on doing. The Mayor stressed there is the opportunity if you work together and put petty differences aside and just put the City first to create the City that we all want to see.

It's a tremendous opportunity, it's a tremendous challenge, but it's right there before you and you can do it if you want.

Mayor Peloquin cannot explain how gratifying it is to have all the people here tonight and he knows some of them just want to make sure he's leaving. He has made so many friends and he does not want them to think that they will not continue to be friends. He will be there to help everybody on the City Council, any of the Department Heads or anyone in regards to making our City a better place.

Mayor Peloquin asked the Aldermen in his Ward to make the motion to adjourn this City Council Meeting and the 28-years of his tenure of being Mayor.

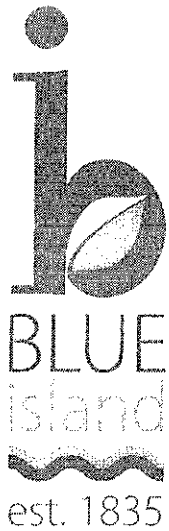
