**WHEREAS**, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12;

**WHEREAS**, the City has elected to participate in Cook County's Community Development Block Grant Program 2019 Subrecipient Agreement attached as Exhibit "A";

**WHEREAS**, the appropriate city officials have considered and reviewed the 2019 Subrecipient Agreement attached as Exhibit "A" and find it to be in the best interests of the City;

**NOW AND THEREFORE, BE IT RESOLVED** by the City Council of the City of Blue Island, Cook County, Illinois, as follows:

**SECTION 1: AGREEMENT FORM AND TERMS AUTHORIZED**

The terms and conditions as shown in the Agreement attached as Exhibit A to this Resolution are hereby approved.

**SECTION 2: AUTHORIZATION OF MAYOR & AGENT TO EXECUTE AND ACT IN ACCORDANCE WITH AGREEMENT**

The City Council approves the Community Development Block Grant Program 2019 Subrecipient Agreement attached hereto as Exhibit "A" and authorizes the Mayor, City Clerk and City Attorney to execute the agreement and any and all documentation that may be necessary to carry out the intent of this Resolution. The officers, employees and/or agents of the City shall take all action necessary or reasonably required by the City to carry out, give effect to, and consummate the intent of this Resolution.

### **SECTION 3: EFFECTIVE DATE**




