**RESOLUTION NO. 2020-029**

**A RESOLUTION APPROVING AND AUTHORIZING A MEMORANDUM OF UNDERSTANDING WITH MACON COUNTY LAW ENFORCEMENT TRAINING CENTER (MCLETC) TO PROVIDE THE CITY OF BLUE ISLAND WITH TWO COMMITTED TRAINING POSITIONS IN THE THREE ANNUAL POLICE ACADEMY TRAINING CLASSES CONDUCTED BY MCLETC**

WHEREAS, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12;

WHEREAS, the City plans to enter into a Memorandum of Understanding with Macon County Law Enforcement Training Center (MCLETC) to provide the City with two (2) committed training positions in the three (3) annual police academy training classes conducted by MCLETC, as more fully described in Exhibit "A" to this Resolution; and

WHEREAS, the appropriate city officials have considered and reviewed the contract attached as Exhibit A and find the same to be in the best interests of the City;

NOW AND THEREFORE, BE IT RESOLVED by the City Council of the City of Blue Island, Cook County, Illinois, as follows:

SECTION 1: AGREEMENT FORM AND TERMS AUTHORIZED. The terms and conditions as shown in the Letter of Agency attached as Exhibit A to this Resolution are hereby approved.

SECTION 2: AUTHORIZATION OF MAYOR TO EXECUTE AND ACT IN ACCORDANCE WITH AGREEMENT. The City Council approves the Memorandum of Understanding with Macon County Law Enforcement Training Center (MCLETC) to provide the City with two (2) committed training positions in each of its three (3) annual police academy training classes in exchange for the city's commitment to use MCLETC when necessary for training. The City Council further authorizes the Mayor or his designee to execute any and all documentation that may be necessary to carry out the intent of this Resolution. The officers,

employees, and/or agents of the City shall take all action necessary or reasonably required by the City to carry out, give effect to, and consummate the intent of this Resolution.

SECTION 3: EFFECTIVE DATE. This resolution shall be in full force and effect upon its passage, approval and publication as required by law.
