**A RESOLUTION APPROVING AND AUTHORIZING AN AGREEMENT
FOR SERVICES WITH GRIZZ PEST MANAGEMENT, INC.**

WHEREAS, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12;

WHEREAS, the City plans to enter into an Agreement with Grizz Pest Management, Inc. for pest control targeting Norway Rats, as more fully described in Exhibit “A” to this Resolution; and

WHEREAS, the appropriate city officials have considered and reviewed the Agreement with Grizz Pest Management, Inc. attached as Exhibit A and find the same to be in the best interests of the City;

NOW AND THEREFORE, BE IT RESOLVED by the City Council of the City of Blue Island, Cook County, Illinois, as follows:

SECTION 1: AGREEMENT FORM AND TERMS AUTHORIZED. The terms and conditions as shown in the Law Enforcement Agreement attached as Exhibit A to this Resolution are hereby approved.

SECTION 2: AUTHORIZATION OF MAYOR TO EXECUTE AND ACT IN ACCORDANCE WITH AGREEMENT. The City Council approves the Agreement with Grizz Pest Management, Inc. for pest control targeting Norway Rats, and authorizes the Mayor or his designee to execute any and all documentation that may be necessary to carry out the intent of this Resolution. The officers, employees, and/or agents of the City shall take all action necessary or reasonably required by the City to carry out, give effect to, and consummate the intent of this Resolution.

SECTION 3: EFFECTIVE DATE. This resolution shall be in full force and effect upon its passage, approval and publication as required by law.

The initial term of this agreement is for one year from the date hereof and it shall continue in full force and effect after the initial term unless cancelled by either party upon not less than 30 days written notice. After the expiration of the initial term, Grizz Pest Management, Inc. reserves the right, upon sufficient notice, to modify the cost of the service at any time. 3. This Agreement is contingent upon strikes, lockouts, or other labor trouble and war, fire, flood, and other contingencies beyond the control of the Grizz Pest Management, Inc. Company. 4. It is understood by the client that pest management services may involve the use of toxic substances and that Grizz Pest Management, Inc. assumes no responsibility or control over the hazards involved in the use of these substances beyond reasonable care in their application. 5. Grizz Pest Management, Inc. assumes no liability for any property damage done by any pests prior to, during or subsequent to any treatment by Grizz Pest Management, Inc. In any event, the full extent of Grizz Pest Management, Inc.'s liability under this Agreement shall be limited to the services charges paid under this Agreement subject to any applicable Statute of Limitations. 6. Grizz Pest Management, Inc. reserves the right to modify any terms of this Agreement where performance of treatment may result in violation of Federal, State, or Local Rules and Regulations or Industrial Practices or Labeling Instructions.
