**A RESOLUTION APPROVING AND AUTHORIZING A
CONTRACT WITH DOTY & SONS CONCRETE PRODUCTS, INC.
FOR TOWN SQUARE LITTER RECEPTACLES**

WHEREAS, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12;

WHEREAS, the City plans to enter into a contract with Doty & Sons Concrete Products, Inc. at a total cost of \$19,880.40 for the purchase of thirty-two (32) Town Square concrete litter receptacles for placement throughout the City;

WHEREAS, the appropriate city officials have considered and reviewed the quotation attached as Exhibit A and find it to be in the best interests of the City;

NOW AND THEREFORE, BE IT RESOLVED by the City Council of the City of Blue Island, Cook County, Illinois, as follows:

SECTION 1: AGREEMENT FORM AND TERMS AUTHORIZED

The terms and conditions as shown in the Agreement attached as Exhibit A to this Resolution are hereby approved.

**SECTION 2: AUTHORIZATION OF MAYOR & AGENT TO EXECUTE AND ACT IN
ACCORDANCE WITH AGREEMENT**

The City Council approves a contract with Doty & Sons Concrete Products, Inc. at a total cost of \$19,880.40 for the purchase of thirty-two (32) Town Square concrete litter receptacles and authorizes the Mayor or his designee to execute any and all documentation that may be necessary to carry out the intent of this Resolution. The officers, employees, and/or agents of the City shall take all action necessary or reasonably required by the City to carry out, give effect to, and consummate the intent of this Resolution.

SECTION 3: EFFECTIVE DATE

This resolution shall be in full force and effect upon its passage, approval and publication as required by law.


