ORDINANCE NO. 2015-037

**AN ORDINANCE REGULATING THE DIRECTION OF VEHICULAR TRAFFIC
WITHIN THE CITY OF BLUE ISLAND, STATE OF ILLINOIS**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

It shall be unlawful to operate a vehicle on a one-way street except in the indicated direction. Vehicular traffic shall be allowed as designated for the following:

Irving Avenue: The portion of Irving Avenue from the intersection of Irving Avenue and Broadway Street, proceeding north on Irving Avenue to the intersection with Canal Street, is hereby designated a one-way street for northbound traffic only.

Gregory Street: The portion of Gregory Street between the intersections of Canal Street and Broadway Street is hereby designated a two-way street for both northbound and southbound traffic.

SECTION TWO

Appropriate signs shall be erected on the streets hereinabove set forth, informing the public regarding the direction of vehicular traffic as provided.

SECTION THREE

All ordinances in conflict with the provisions set forth herein are hereby repealed to the extent that said ordinances regulate the direction of vehicular traffic on the identified streets.

SECTION FOUR

This ordinance shall be in full force and effect beginning on January 1, 2016. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as corporate authorities.
