ORDINANCE NO. 2016-009

AN ORDINANCE AUTHORIZING DISPOSITION OF CERTAIN PERSONAL PROPERTY OWNED BY THE CITY OF BLUE ISLAND

WHEREAS, the City Council is authorized to dispose of personal property of the city pursuant to 65 ILCS 5/11-76-4 when such property is no longer necessary or useful to, or for the best interests of the city,

WHEREAS, the City Council may authorize the sale of that personal property in such manner as they may designate, with or without advertising the sale.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook, and State of Illinois:

SECTION ONE: DECLARATION OF USEFULNESS

The police department is in possession of certain vehicles which are in a state of disrepair and cannot otherwise be driven and have not been in use. The fire department is in possession of a certain ambulance which is in a state of extreme disrepair and the costs of repair exceed the value of the ambulance and such ambulance has not been in use by the department. Said personal property as set forth in Exhibit A attached hereto is hereby declared to be surplus and is unnecessary and no longer useful to the city and shall be disposed of as set forth in section two.

SECTION TWO: TERMS OF DISPOSITION OF PERSONAL PROPERTY

City officials shall, without the requirement of advertisement or bids, dispose of the personal property described herein by sale or salvage for an amount deemed reasonable by the officials.

SECTION THREE: REPEAL OF ORDINANCES

All ordinances, and parts thereof, in conflict with the provisions herein are repealed.

SECTION FOUR: EFFECTIVE DATE
