ORDINANCE NO. 2016-029

AN ORDINANCE ESTABLISHING A SCHEDULE OF ALDERMANIC ELECTIONS FOR THE WARDS OF THE CITY OF BLUE ISLAND

WHEREAS, the wards of the City of Blue Island had not been redistricted since 1996; and

WHEREAS, the City of Blue Island has redistricted its wards in order to ensure compliance with all State and federal requirements and to ensure that all citizens are afforded an equal opportunity to participate in the political process elect candidates of their choice; and

WHEREAS, the Blue Island system of staggered terms for alderman will be maintained,
and

WHEREAS, any Aldermen elected under the prior Ward boundaries will continue to represent the Ward from which they were elected for the remainder of their term in office;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, that:

SECTION ONE

The City of Blue Island establishes an Aldermanic election schedule in years 2017 and 2019 as follows:

SECTION TWO

Beginning in calendar year 2021, and at each subsequent election, the term of each Alderman elected from each of the seven wards will be for four years.

SECTION THREE

Each election will occur at the Consolidated Election as provided in Section 2A-1.1 of the Election Code. 10 ILCS 5/2A-1.1.


SECTION SIX


