ORDINANCE NO. 2017- 023

AN ORDINANCE RESTRICTING A PORTION OF A CERTAIN STREET AT OR NEAR 2433 OAK STREET FOR HANDICAPPED PARKING ONLY WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, it is the public policy of the State of Illinois, as enunciated in the State Constitution, that handicapped persons are entitled to enjoy the fruits of a full and meaningful life; and

WHEREAS, the Mayor and City Council of the City of Blue Island hereby declare that it is the public policy of the city to encourage and assist handicapped persons to participate fully in the social and economic life of our community; and

WHEREAS, to implement such policy the Mayor and City Council of the City of Blue Island recognize it is desirable to restrict certain portions of the public ways within the City of Blue Island for handicapped parking only;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

That this portion of the street within the City of Blue Island, as hereinafter designated, is hereby restricted for handicapped parking only:

- a) On the south side of Oak Street in front of the residence whose common address is 2433 Oak Street (one space consisting of a total of twenty (20') feet)

SECTION TWO

Appropriate signs shall be erected by the Superintendent of Public Works on the portion of the street designated above informing the public that parking thereon is restricted or permitted as hereinabove provided for.

SECTION THREE

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction be fined not less than Two Hundred Fifty Dollars (\$250.00) nor more than Three Hundred Fifty Dollars (\$350.00) for each offense.

SECTION FOUR

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION FIVE







**Request for Installation of Handicapped Parking Signage
2433 Oak**

I. Introduction/Purpose

Resident has requested the installation of handicapped parking signage in front of the parkway of her residence.

II. Discussion/Highlights

A request for installation of handicapped signage has been initiated by Barbara Signore, a resident at 2433 Oak Street. The property is a single family home with a garage located in the alley. Mrs. Signore suffers from degenerative arthritis in her knees, hip and back and is unable to open the overhead door alone. There is no one in the household available during the day to assist her. Mrs. Signore has a sidewalk located in her parkway and has requested handicapped parking directly to the left of the sidewalk to allow relatively easy access to her vehicle.

III. Conclusion/Recommendation

After interviewing Mrs. Signore it is recommended, given her restricted mobility, that the handicapped signage request be approved.
