ORDINANCE NO. 2018- 039

AN ORDINANCE RESTRICTING A PORTION OF A CERTAIN STREET AT OR NEAR 2328 W. 121ST PLACE FOR HANDICAPPED PARKING ONLY WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, it is the public policy of the State of Illinois, as enunciated in the State Constitution, that handicapped persons are entitled to enjoy the fruits of a full and meaningful life; and

WHEREAS, the Mayor and City Council of the City of Blue Island hereby declare that it is the public policy of the city to encourage and assist handicapped persons to participate fully in the social and economic life of our community; and

WHEREAS, to implement such policy the Mayor and City Council of the City of Blue Island recognize it is desirable to restrict certain portions of the public ways within the City of Blue Island for handicapped parking only;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

That this portion of the street within the City of Blue Island, as hereinafter designated, is hereby restricted for handicapped parking only:

- a) On the north side of 121st Place in front of the residence whose common address is 2328 W. 121st Place (one space consisting of a total of twenty (20') feet)

SECTION TWO

Appropriate signs shall be erected by the Superintendent of Public Works on the portion of the street designated above informing the public that parking thereon is restricted or permitted as hereinabove provided for.

SECTION THREE

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction be fined not less than Two Hundred Fifty Dollars (\$250.00) nor more than Three Hundred Fifty Dollars (\$350.00) for each offense.

SECTION FOUR

All ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION FIVE

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as Corporate Authorities.







Request for Handicapped Parking Signage

Introduction/Purpose

Resident has requested the installation of handicapped parking signage in front of the parkway of her residence.

Discussion/Highlights

A request for installation of handicapped signage has been initiated by Mrs. Maria Rosario, a resident at 2328 W. 121st Place. The property is a single family home with a garage in the back. The applicant stated she suffers from chronic lower back pain and osteoarthritis in both knees limiting her ability to walk.

Conclusion

When asked about using the garage, Mrs. Rosario said the garage was too structurally unsound to put a vehicle in which is why she requested parking to be authorized in front of the house. A visual inspection by the City confirmed it should be replaced but did not appear to be a danger at this point. Resident stated she is not currently in a position to address it.

Once the form and copy of placard are submitted to the Clerk's Office, City Staff will visit the address to verify the following:

Is there a driveway? No

Is there a garage? Yes

Is there a fire hydrant in front of the residence? No

Is there any reason that the request cannot be fulfilled? No

If the answer to ALL of these questions is no, both Aldermen of the Ward will be notified of the request and it can be sent to the City Attorney to draft an ordinance.
