ORDINANCE NO. <u>2018-060</u>

AN ORDINANCE DECLARING SURPLUS REVENUE IN THE CITY OF BLUE ISLAND TIF 3 DISTRICT SPECIAL TAX ALLOCATION FUND AND AUTHORIZING THE PAYMENT OF THAT SURPLUS REVENUE TO THE COOK COUNTY TREASURER FOR DISTRIBUTION TO THE AFFECTED TAXING DISTRICTS ON A PRO RATA BASIS

WHEREAS, pursuant to Ordinance No. 94-250, No. 94-251 and No. 94-252, adopted January 11, 1994, as supplemented and amended, the City of Blue Island (the "Municipality") adopted a redevelopment plan and a related redevelopment project (the "Redevelopment Plan" and "Redevelopment Project"), designated the TIF #3 redevelopment project area (the "Redevelopment Project Area") (as described on the attachment to this ordinance) and adopted tax increment finance for the redevelopment project area;

WHEREAS, the City Clerk has notified all affected taxing districts that the designation of the Redevelopment Project Area for TIF # 3 will terminate on December 31, 2018 in accordance with provisions pursuant to Section 11-74.4-8 of the TIF Act; and

WHEREAS, the Corporate Authorities have determined upon the termination of TIF #3 Redevelopment Project Area that there is an excess of monies to be declared as surplus in the special tax allocation fund held for Redevelopment Project Area for TIF #3 in the sum of \$1,469,724.02, and that said amount shall be paid to Cook County for distribution to the affected taxing districts in proportion to the most recent distribution of real estate property taxes from property in the Redevelopment Project Area for TIF #3;

WHEREAS, Mayor and City Council have received the certification of the Municipality's Finance Director that all obligations in connection with the Redevelopment Project Area have been retired and that all excess monies will be distributed, and notice of the dissolution of the special tax allocation fund and the termination of the Redevelopment Project Area will be given by the City Clerk prior to December 31, 2018 to all affected taxing districts.

NOW, THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE CITY OF BLUE ISLAND, ILLINOIS, as follows:

- Section 1. The Municipality hereby dissolves the special tax allocation fund for the Redevelopment Project Area and terminates the Redevelopment Project Area as a "Redevelopment Project Area" under the Act.
 - **Section 2.** The City Clerk shall immediately file a certified copy of this ordinance with the County of Cook County, Illinois.
 - **Section 3**. This ordinance shall become effective immediately upon its passage and approval.



WHEREAS, the City Clerk has notified all affected taxing districts that the designation of the Redevelopment Project Area for TIF # 3 will terminate on December 31, 2018 in accordance with provisions pursuant to Section 11-74.4-8 of the TIF Act; and

WHEREAS, the Corporate Authorities have determined upon the termination of TIF #3 Redevelopment Project Area that there is an excess of monies to be declared as surplus in the special tax allocation fund held for Redevelopment Project Area for TIF #3 in the sum of \$1,469,724.02, and that said amount shall be paid to Cook County for distribution to the affected taxing districts in proportion to the most recent distribution of real estate property taxes from property in the Redevelopment Project Area for TIF #3;

WHEREAS, Mayor and City Council have received the certification of the Municipality's Finance Director that all obligations in connection with the Redevelopment Project Area have been retired and that all excess monies will be distributed, and notice of the dissolution of the special tax allocation fund and the termination of the Redevelopment Project Area will be given by the City Clerk prior to December 31, 2018 to all affected taxing districts.

NOW, THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE CITY OF BLUE ISLAND, ILLINOIS, as follows:

- Section 1. The Municipality hereby dissolves the special tax allocation fund for the Redevelopment Project Area and terminates the Redevelopment Project Area as a "Redevelopment Project Area" under the Act.
- Section 2. The City Clerk shall immediately file a certified copy of this ordinance with the County of Cook County, Illinois.
- Section 3. This ordinance shall become effective immediately upon its passage and approval.
