ORDINANCE NUMBER 2021-001

**AN ORDINANCE REQUIRING VEHICULAR TRAFFIC TO STOP AT A CERTAIN LOCATION WITHIN THE CITY OF BLUE ISLAND, COOK COUNTY, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF
(Maple Avenue and 122nd Place)**

BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

For the purpose of this ordinance an intersection is defined as that portion of said streets lying within the prolongation of the lateral curb lines of each other.

SECTION TWO

The operator of any vehicle proceeding on the street and in the direction hereinafter designated, said street being within the city of Blue Island, shall stop such vehicle at the stop signs hereinafter provided before proceeding, except when directed to proceed by a police officer or as otherwise provided by law:

- (a) Northbound on Maple Avenue at its intersection with 122nd Place.
- (b) Southbound on Maple Avenue at its intersection with 122nd Place.
- (c) Eastbound on 122nd Place at its intersection with Maple Avenue.

SECTION THREE

Appropriate traffic signs shall be erected by the Superintendent of Public Works on each corner at or near the intersection of Maple Avenue and 122nd Place, informing the public that vehicular traffic traveling in every direction must stop before said intersection.

SECTION FOUR

The operator of any vehicle violating or failing to comply with any provisions of this ordinance shall be fined not less than Twenty-Five Dollars (\$25.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

SECTION FIVE

If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION SEVEN


This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.




