ORDINANCE NUMBER 2021-013A

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,
AMENDING CHAPTER 30, "CITY COUNCIL," OF TITLE III, "ADMINISTRATION,"
OF THE CODE OF BLUE ISLAND, ILLINOIS**

WHEREAS, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing city created under the provisions of the laws of the State of Illinois and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the Mayor and the Aldermen of the City (the "*City Council*," or the "*Corporate Authorities*") are committed to ensuring the effective and efficient administration of government; and

WHEREAS, the Corporate Authorities may from time to time amend the text of the Code of Blue Island, Illinois when it is determined to be in the best interests of the City and the residents of the City; and

WHEREAS, the Corporate Authorities find that the following amendments of the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Corporate Authorities of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Corporate Authorities find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the public interest.

Section 3. That Section 30.01 (“*Meetings of City Council*”) of Chapter 30 (“*City Council*”) of Title III (“*Administration*”) of the Code of Blue Island, Illinois is hereby amended by deleting the following stricken language and adding the underlined language as follows:

§30.01 MEETINGS OF CITY COUNCIL.

(A) The regular meeting of the City Council shall be held at 7:00 p.m. CST on the second and fourth Tuesdays of each calendar month, except that during December, the City Council shall meet on the second and ~~third~~ Tuesdays.

(B) The regular meeting of the Committee of the Whole of the City Council shall be held at 6:00 p.m. CST on the second Wednesdays of each calendar month.

Section 4. That Section 30.15 (“*Standing Committees of City Council*”) of Chapter 30 (“*City Council*”) of Title III (“*Administration*”) of the Code of Blue Island, Illinois is hereby amended by deleting the aforesaid section in its entirety and adding the underlined language as follows:

§30.15 COMMITTEE LIAISONS.

Operating as committee liaisons within the Committee of Whole and the City Council, each alderman shall be assigned a committee liaison assignment with responsibility over a respective operational area of the City in an effort to foster policy direction and leadership regarding specific community needs. The seven operational areas of the City to be assigned a committee liaison shall be as determined by the City Council.

Section 5. That Section 30.16 (“*Membership in Committees*”) of Chapter 30 (“*City Council*”) of Title III (“*Administration*”) of the Code of Blue Island, Illinois is hereby amended by deleting the aforesaid section in its entirety and adding the underlined language as follows:

§30.16 MEMBERSHIP IN COMMITTEES.

(A) The City Council shall appoint an alderman as the committee liaison for each respective operational area of the City assigned a committee liaison.

(B) Each committee member shall be notified in writing of the committee liaison assignment for which he or she is to serve and shall continue to serve as such liaison until notified in writing to the contrary.

Section 6. That Section 30.17 (“*Written Reports of Committees*”) of Chapter 30 (“*City Council*”) of Title III (“*Administration*”) of the Code of Blue Island, Illinois is hereby amended by deleting the following stricken language and adding the underlined language as follows:

§30.17 WRITTEN REPORTS OF COMMITTEES.

The committee ~~chairperson~~ liaison or, in his or her absence, their designee ~~another member of the committee~~, in reporting upon a subject ~~referred to~~ of the liaison assignment committee, shall report in writing to the Committee of the Whole or the City Council unless such written report is excused by the Mayor. All written reports of any committee liaison and all papers, petitions and other documents relative to a ~~committee~~ liaison’s report shall be placed on file in the City Clerk’s Office and shall become a part of the official city records.

Section 8. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 9. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 10. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
