**ORDINANCE NUMBER 2021-18**

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, ILLINOIS RESTRICTING A PORTION OF A CERTAIN STREET AT OR NEAR 12458 MAPLE AVENUE FOR HANDICAPPED PARKING ONLY WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, it is the public policy of the State of Illinois, as enunciated in the State Constitution, that handicapped persons are entitled to enjoy the fruits of a full and meaningful life; and

**WHEREAS**, the Mayor and City Aldermen of the City of Blue Island hereby declare that it is the public policy of the City to encourage and assist handicapped persons to participate fully in the social and economic life of our community; and

**WHEREAS**, a resident has submitted an application to the City for a handicapped parking sign at the 12458 Maple Avenue; and

**WHEREAS**, Section 72.14 of the Blue Island Municipal Code sets forth the regulations for handicapped parking within the City; and

**WHEREAS**, the requirements of Section 72.14(B) are hereby waived to the fullest extent allowed by law; and

**WHEREAS**, the Mayor and City Aldermen of the City of Blue Island find that the implementation of such policy is in the best interests of the health, safety and welfare of the City and its residents;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, County of Cook and State of Illinois, as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

**Section 3.** That, as prescribed by Section 72.14 of the Blue Island Municipal Code, the portion of the street within the City, as hereinafter designated, is hereby restricted for handicapped parking only:

- a) One space consisting of a total of twenty (20') feet on the west side of Maple Avenue in front of the residence whose common address is 12458 Maple Avenue.

**Section 4.** Appropriate signs shall be erected by the Superintendent of Public Works on the portion of the street designated above informing the public that parking thereon is restricted or permitted as hereinabove provided for.

**Section 5.** The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall, upon conviction, be fined not less than Three Hundred Fifty Dollars (\$350.00) for each offense.

**Section 6.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 7.** All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 8.** This Ordinance shall be in full force and effect upon its passage, approval, and publication as provided by law.
