**ORDINANCE NUMBER 2021-26**

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,  
REGARDING THE SALE OF PERSONAL SURPLUS PROPERTY OWNED  
BY THE CITY**

---

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing city created under the provisions of the laws of the State of Illinois and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and Aldermen of the City have the authority pursuant to 65 ILCS 5/11-76-4 to deem personal property owned by the City to be no longer necessary or useful to the best interests of the City and to authorize the conveyance of said property in such manner as the City may designate; and

**WHEREAS**, the Mayor and Aldermen have identified City owned property that is no longer used or required by the City, said property being identified and described on Exhibit A (the “*Surplus Property*”), a copy of which is attached hereto and made a part hereof; and

**WHEREAS**, it is the opinion of the Mayor and Aldermen of the City of Blue Island that the Surplus Property is no longer necessary, useful or serving the best interests of the City and that offering the Surplus Property for sale is in the best interest of the City in order to protect the health, safety and welfare of its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct



and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the public interest.

**Section 3.** The Mayor and Aldermen find that the Surplus Property is no longer necessary or useful to the City and that the best interest of the City will be served from the sale of the Surplus Property, as identified and described on Exhibit A.

**Section 4.** The officials and officers of the City are hereby authorized and directed to sell the Surplus Property, as identified and described on Exhibit A to the party offering the highest purchase price in “*as is condition with all known and unknown faults*”, unless a bidding party is a taxing body then the taxing body will receive priority.

**Section 5.** The officials and officers of the City are hereby further authorized to undertake actions on the part of the City to effectuate the sale and transfer of the Surplus Property.

**Section 8.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 9.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 10.** This Ordinance shall be in full force and effect immediately upon its passage and approval to ensure the public health, safety and welfare of the residents of the City
