**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS
AUTHORIZING RESIDENTIAL ONLY PARKING ON THE WEST SIDE OF WOOD
STREET BETWEEN 127TH STREET AND VERMONT STREET IN THE
CITY OF BLUE ISLAND, COOK COUNTY ILLINOIS**

WHEREAS, the City of Blue Island, Cook County, Illinois (the “City”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, Title VII, Chapter 72, Section 72.09 of the Blue Island, Illinois Code of Ordinances (“City Code”) allows the City to create restricted parking areas from time to time;

WHEREAS, the Mayor and City Aldermen desire to create a residential only parking restriction on the west side of Wood Street between 127th Street and Vermont Street; and

WHEREAS, the Mayor and City Aldermen find that the following residential parking restriction is in the best interests of the health, safety and welfare of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

Section 3. No nonresidential persons shall stop, stand, or park on Wood Street between 127th Street and Vermont Street.

Section 4. The operator of any vehicle violating or failing to comply with any provisions of this ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Seven Hundred and Fifty Dollars (\$750.00) for each offense.

Section 5. Appropriate signs shall be erected by Public Works Department on the street designated above informing the public regarding the Residential Only Parking Requirement.

Section 6. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 7. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 8. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


