**ORDINANCE NUMBER 2021-055**

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,  
AMENDING SECTION 30.01, "MEETINGS OF CITY COUNCIL" OF CHAPTER  
30, "CITY COUNCIL" OF TITLE III, "ADMINISTRATION" OF  
THE CODE OF BLUE ISLAND, ILLINOIS**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the "*Code*") when it is determined to be in the best interests of the health, safety and welfare of the Village and its residents; and

**WHEREAS**, the City currently has an interest in revising this section of the Code to change the date and time of City Council's Committee of the Whole monthly meetings; and

**WHEREAS**, the Mayor and City Aldermen find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and Aldermen of the City find and determine that the adoption of this Ordinance is in the best interest of the City as well as in the best interests of the public.

**Section 3.** That Section 30.01 (“*Meetings of the City Council*”) of Chapter 30 (“*City Council*”) of Title III (“*Administration*”) of the Code of Blue Island, Illinois is hereby amended by deleting the stricken language and adding the underlined language as follows:

**§ 30.01 MEETING OF CITY COUNCIL.**

\*\*\*\*

(B) The regular meeting of the Committee of the Whole of the City Council shall be held at 6:00 p.m. CST on the ~~second~~ first Wednesdays of each calendar month.

(C) The Mayor ~~City administration~~ can make reasonable changes to the scheduling of meetings of City Council without amending the City Code to reflect the same.

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




