**RESOLUTION NUMBER 2021-18**

**A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,  
ESTABLISHING SEVEN OPERATIONAL AREAS WITHIN THE CITY AND  
APPOINTING ALDERMEN AS LIAISONS TO EACH OPERATIONAL AREA**

---

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen of the City of Blue Island seek to establish seven identifiable operational areas with the City for which an alderman will be assigned as a liaison; and

**WHEREAS**, the City Aldermen shall determine the liaison for each Operational Area of the City; and

**WHEREAS**, the Mayor and City Aldermen find that the appointment of certain alderman as liaisons for each Operational Area of the City is in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and City Aldermen find and determine that the adoption of this Resolution is in the best interests of the City as well as in the best interests of the public.

**Section 3.** That the Mayor and Aldermen hereby establishes the following seven Operational Areas within the City:

1. Finance
2. Public Works
3. Marketing
4. Building
5. Police and Fire
6. Golf and Recreation
7. Community Development

**Section 4.** That the Mayor and City Aldermen hereby consent to the appointment of Alderman Joshua Roll as the liaison for Finance operations.

**Section 5.** the Mayor and City Aldermen hereby consent to the appointment of Alderman Bill Fahrenwald as the liaison for Public Works operations.

**Section 6.** That the Mayor and City Aldermen hereby consent to the appointment of Alderman Nancy Rita as the liaison for Marketing operations.

**Section 7.** That Mayor and City Aldermen hereby consent to the appointment of Alderman Luiz Montoya as the liaison for Building operations.

**Section 8.** That Mayor and City Aldermen hereby consent to the appointment of Alderman Gabriel McGee as the liaison for Police and Fire operations.

**Section 9.** That Mayor and City Aldermen hereby consent to the appointment of Alderman Dexter Johnson as the liaison for Golf and Recreation operations.

**Section 10.** That Mayor and City Aldermen hereby consent to the appointment of Alderman Candace Carr as the liaison for Community Development operations.

**Section 11.** The Mayor and City Aldermen hereby hereby find and determine that the foregoing appointments conform in all respects with Illinois law.

**Section 12.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

**Section 13.** All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 14.** This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as provided by law.
