**A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,
AUTHORIZING AND APPROVING A PROPOSAL BETWEEN THE CITY AND II
BULLS MECHANICAL SERVICES, INC. FOR THE REPLACEMENT
OF THE BLUE ISLAND POLICE DEPARTMENT
AIR CONDITIONING SYSTEM**

WHEREAS, the City of Blue Island, Cook County, Illinois (the “City”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the City desires to retain II Bulls Mechanical Services, Inc. to upgrade the existing air condition system at the Blue Island Police Department pursuant to a Proposal, a copy of which is attached hereto and made a part hereof as Exhibit A (the “Proposal”); and

WHEREAS, 65 ILCS 5/8-9-1 of the Illinois Municipal Code authorizes the City to enter into contracts for work, public improvement, or supplies in excess of \$20,000 without advertising for bids if authorized by vote of two-thirds of all the aldermen then holding office; and

WHEREAS, the Mayor and Aldermen of the City of Blue Island deem it advisable and in the best interests of the health, safety and welfare of the residents of the City to waive bidding requirements pursuant to 65 ILCS 5/8-9-1 and accept the proposal to upgrade the air conditioning system by II Bulls Mechanical Services, Inc.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct

and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and Aldermen find and determine that the adoption of this Resolution is in the best interests of the City as well as in the best interests of the public.

Section 3. The Proposal provided by II Bulls Mechanical Services, Inc. regarding the services to be completed, which is attached hereto and made a part hereof as Exhibit A, is hereby approved in substantially the same form presented to the Mayor and Aldermen with such necessary non-material changes as may be authorized by the Mayor to execute the Proposal, the execution of which constitutes the approval by the City of any and all changes or revisions therein contained.

Section 4. The officials and officers of the City are hereby authorized to undertake actions on the part of the City as contained in the Proposal to complete satisfaction of the provisions, terms or conditions stated therein.

Section 5. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.
