ORDINANCE NUMBER 2022- 007

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY,  
ILLINOIS, AMENDING TITLE III, CHAPTER 39, “FEE AND FINE  
SCHEDULE” OF THE CODE OF BLUE ISLAND, ILLINOIS**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the “*Code*”) when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

**WHEREAS**, Public Act 102-0689, effective December 17, 2021, made several changes to Illinois’ video gaming laws that impact non-home rule communities, specifically allowing non-home rule communities to impose an annual fee for the operation of each video gaming terminal not to exceed \$250.00 per year.

**WHEREAS**, the Mayor and City Aldermen desire to modify the Code to ensure that the City’s fees for video gaming terminals are consistent with Illinois law; and

**WHEREAS**, the Mayor and City Aldermen find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and City Aldermen find and determine that the adoption of this

Ordinance is in the best interests of the City as well as in the best interests of the public.

**Section 3.** That Chapter 39 ("*Fee and Fine Schedule*") of Title III ("*Administration*") of the Code of Blue Island, Illinois is hereby amended by deleting the stricken language and adding the underlined language as follows:

**§ 39.01 FEE AND FINE SCHEDULE.**

(C) *Clerk's office.*

Miscellaneous	
Emblems (such as poker, games and the like)	
<del>Poker</del> <u>Gambling Device</u>	<del>\$25.00</del> <u>250.00</u> per machine device.

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


