ORDINANCE NUMBER 2022- 011

AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, AMENDING CHAPTER 110, "GENERAL LICENSING PROVISIONS" OF THE CODE OF BLUE ISLAND, ILLINOIS

WHEREAS, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the "*Code*") when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

WHEREAS, the City currently regulates business licensing throughout the City; and

WHEREAS, the Mayor and City Aldermen desire to modify the Code and create efficient and effective systems for the regulation and enforcement of business licensing within the City; and

WHEREAS, the Mayor and City Aldermen find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

Section 3. That Section 110.47 (*“Revocation of Business License”*) of Chapter 110 (*“General Licensing Provisions”*) of Title XI (*“Business Regulations”*) of the Code of Blue Island, Illinois is hereby amended by deleting the stricken language and adding the underlined language as follows:

§ 110.45 GENERAL ENFORCEMENT

Any license issued to any person or entity or any pending application for a license to be reviewed according to this chapter may be denied, suspended or revoked because of any violation of this chapter, or of any other ordinance of the city, or of any state or federal law, or whenever the registrant or applicant shall cease to meet the standards and requirements as set forth in this chapter. Additional penalties or remedies which may be imposed include modification of the license terms or permitted business operations, fines and other remedies appropriate and tailored to addressing or correcting the violations.

§ 110.47 REVOCATION OR DENIAL OF BUSINESS LICENSE

(A) Licenses issued by the city may be revoked or pending applications for licenses may be denied by the Mayor or his or her designee upon the recommendation of city officials ~~after notice and hearing as provided in this chapter~~, for any of the following causes:

(B) Any revocation or denial shall not preclude prosecution and imposition of any other penalties for the violation of other city ordinances. No person whose license has been denied or revoked shall be eligible for a new license for a period of 12 months.

§ 110.49 HEARING PROCEDURES ON VIOLATIONS FOR DENIALS, SUSPENSIONS, OR REVOCATIONS

(A) Upon written request by the applicant or licensee to the City Clerk, the Mayor or designee shall hold a hearing within five business days after receipt of such request for the purposes of determining whether or not the license or permit shall be revoked or remain suspended or denied and what fines or penalties, if any, shall be imposed.

(B) Notice of the hearing for denial, suspension or revocation of a license shall be given in writing, setting forth the grounds of the complaint and the time and place of the hearing. The method of such notice shall be either by:

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
