**ORDINANCE NUMBER 2022- 058**

**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,  
ESTABLISHING RESIDENTIAL PERMIT PARKING OF MOTOR VEHICLES ON THE  
EAST AND WEST SIDES OF 128<sup>TH</sup> FRANCISCO AVE.**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “City”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the City Code of Blue Island allows the City to regulate parking;

**WHEREAS**, the Mayor and City Aldermen desire to designate residential parking, specifically Permit Parking Only, on both sides of the street on 128<sup>th</sup> and Francisco Avenue due to an increase of parking on that block by high school students attending Eisenhower High School, which has significantly reduced the amount of parking available to residents of the block;

**WHEREAS**, the Mayor and City Aldermen find that designating that street as residential permit only parking is in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

**Section 3.** The east and west sides of Francisco Avenue on 128<sup>th</sup> Street, within the City of Blue Island, is hereby designated Permit Parking Only Zone B-10.

**Section 4.** The operator of any vehicle violating or failing to comply with any provisions of this ordinance shall be fined not less than Fifty Dollars (\$50.00) nor more than Seven Hundred and Fifty Dollars (\$750.00) for each offense.

**Section 5.** Appropriate signs shall be erected by Public Works Department on the street designated above informing the public regarding the Residential Parking restrictions.

**Section 6.** Upon receipt of an application and appropriate proof of actual residence within the Residential Permit Parking Only Zone B-10, the City Clerk is hereby authorized to issue annual "Residential Parking Permit" decals to residents of the District whose principal place of residence is located in the district.

**Section 7.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 8.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 9.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




