**AN ORDINANCE OF THE CITY OF BLUE ISLAND,  
COOK COUNTY, ILLINOIS, AMENDING TITLE XV: (“LAND USAGE”) CHAPTER  
150 (BUILDING REGULATIONS; CONSTRUCTION”), SECTION 150.101  
 (“CONSTRUCTION SPECIFICATIONS”) OF THE CITY CODE TO ADDRESS FINES  
RELATING TO FAILURE TO MAINTAIN OFF-STREET PARKING AREAS**

---

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen may from time to time amend ordinances of the City when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

**WHEREAS**, the Mayor and City Alderman have reviewed the current ordinance and have determined that it is necessary to amend the City Code to allow the City to issue citations and fines for non-compliance with construction specifications for off-street parking areas.

**WHEREAS**, the Mayor and City Aldermen find that the following amendments to Title XV, Chapter 150, Section 150.101 of the City Code, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

**Section 3.** That Section 150.101 (“*Construction Specifications*”) of Chapter 150 (“*Building Regulations; Construction*”) of Title XV (“*Land Usage*”) is hereby amended by striking language and adding underlined language as follows:

**Section 150.101 Construction Specifications**

All off-street parking areas, loading facilities and driveways required by the city shall be constructed with concrete or asphalt surfaces and shall conform to the following standards.

(E) Penalty, see §10.99

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


