**A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,
APPROVING AND AUTHORIZING THE PURCHASE OF
VEHICLES FOR THE POLICE AND FIRE DEPARTMENTS IN ACCORDANCE WITH
THE PROPOSAL FROM FORD CREDIT MUNICIPAL FINANCE**

WHEREAS, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, For Credit Municipal Finance provided the City with a proposal for purchase and financing of 2022 Ford Inceptor Utility vehicles, which is made a part hereof and attached hereto as **Exhibit A** (the “Proposal”); and

WHEREAS, the Mayor and Aldermen of the City of Blue Island deem it advisable and in the best interests of the health, safety and welfare of the residents of the City to these vehicles for the City’s Police and Fire Departments, based on the proposal in **Exhibit A**.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Proposal attached hereto as **Exhibit A**, and vehicle purchase associated with the same, is hereby approved in substantially the same form presented by the Proposal in **Exhibit A**.

Section 3. The officials and officers of the City are hereby authorized to undertake actions on the part of the City as contained in the Proposal to complete satisfaction of the provisions, terms or conditions stated therein.

Section 4. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.


