**ORDINANCE NUMBER 2023-01.5**

**AN ORDINANCE ABATING THE REAL ESTATE TAX HERETOFORE LEVIED FOR THE TAX LEVY YEAR 2022 TO PAY THE DEBT SERVICE ON \$400,388 OF THE WATERWORKS AND SEWAGE REFUNDING BOND (ALTERNATIVE REVENUE SERVICE), SERIES 2006, OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the “City”) is a duly organized and existing city created under the provisions of the laws of the State of Illinois and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and the Aldermen of the City of Blue Island by ordinance adopted in 2006, specifically Ordinance No. 06-046 (the “*Bond Ordinance*”), providing for the issuance of an amount not to exceed \$400,388 Waterworks and Sewage Refunding Bonds (Alternative Revenue Service), Series 2006 (the “*Bonds*”) and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

**WHEREAS**, the Bond Ordinance provides for the levy of taxes in the City’s tax levy year 2022 sufficient for the payment of the principal and interest on the Bonds; and

**WHEREAS**, the City has appropriated from legally available funds an amount sufficient to pay the principal and interest on the Bonds, and said funds are or will be available for the payment of principal and interest on the Bonds when the indebtedness is due; and

**WHEREAS**, it is necessary and in the best interest of the City that the tax heretofore levied in the Bond Ordinance for the tax year 2006 to pay the debt service on the Bonds be abated in its entirety.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Aldermen of the City of

Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** The sum of FOUR HUNDRED THOUSAND, THREE HUNDRED AND EIGHTY-EIGHT DOLLARS AND 00/100 (\$400,388.00) has been determined by the City to be available from legally available funds and shall be irrevocably pledged for the payment of the principal and interest due on the Bonds.

**Section 3.** There is hereby abated the sum of FOUR HUNDRED THOUSAND THREE HUNDRED AND EIGHTY-EIGHT DOLLARS AND 00/100 (\$400,388.00) from the levy of taxes for the City's tax levy year 2022, being the levy set forth in the Bond Ordinance and Bond Order.

**Section 4.** Upon the adoption of this Ordinance, the City Clerk shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said real estate tax levied under the Bond Ordinance for the tax levy year 2022, in accordance with the provisions hereof.

**Section 5.** The officials and officers of the City are hereby authorized to undertake actions on the part of the City to effectuate the abatement herein provided contained.

**Section 6.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**Section 7.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 8.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.


