**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, TO
MODIFY THE COMPENSATION FOR ELECTED OFFICIALS IN THE
CITY OF BLUE ISLAND**

WHEREAS, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the statutes of the State of Illinois and ordinances of the City provide that the compensation for the Mayor and members of City Council are to be established by ordinance; and

WHEREAS, pursuant to the laws of the State of Illinois, specifically, 65 ILCS 5/3.1-50-5, compensation for elected officials may not be increased nor diminished during the terms of office for such officials, and shall be fixed at least 180 days before the beginning of the terms of the officers whose compensation is to be fixed; and

WHEREAS, the Mayor and Aldermen of the City of Blue Island have determined that the salaries of the Mayor and City Aldermen for the next term starting in 2025, should be increased.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. The following annual salary and compensation for elected officials in the City of Blue Island elected to the hereinafter designated offices in the year 2025, as

follows:

<u>OFFICE</u>	<u>SALARY</u>
Mayor	\$50,000
Clerk	\$50,000
Treasurer	\$15,000
Aldermen	\$12,500

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

Section 3. All salaries shall be paid in equal biweekly installments unless provision is made to the contrary by City Council. Applicable deductions as provided by law shall be taken from the salary payments.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


