A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, TO AUTHORIZE AND APPROVE A PROPOSAL BETWEEN THE CITY AND MASERGY TO IMPROVE THE CITY'S WIDE AREA NETWORK

WHEREAS, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the City desires to contract with Masergy for the improvement of its wide area network, in order to accommodate upcoming technology needs, including body cameras, security issues, and network speed, a copy of which is attached hereto and made a part hereof, as <u>Exhibit A</u> (the "*Proposal*"); and

WHEREAS, the Mayor and Aldermen of the City deem it advisable and in the best interest of the health, safety and welfare of the residents of the City to enter into the Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Proposal between the City and Masergy, which is attached hereto and made a part hereof as <u>Exhibit A</u>, is hereby approved in substantially the same form presented to the Mayor and Aldermen with such necessary non-material changes as may be authorized by the Mayor and City Attorney to execute the Agreement, the execution of which constitutes the

approval by the City of any and all changes or revisions therein contained.

Section 4. The officials and officers of the City are hereby authorized to undertake actions on the part of the City as contained in the Agreement to complete satisfaction of the provisions, terms or conditions stated therein.

Section 5. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.

City of Blue Island Wide Area Network (WAN)/SDWAN Connectivity Options February 6th, 2023

Purpose

The purpose of this proposal is to identify 3 vendors that can provide a Wide Area Network, Security Services and Redundancy to the City of Blue Island's technology environment. The solutions will provide enough bandwidth to give the city the flexibility of growth, redundancy to provide a disaster recovery solution and to be protected from viruses, ransomware threats while being monitored 24/7. New firewalls will be deployed and part of the solution. This bandwidth and solution will be running on new fiber optic lines to be installed at all our locations.

Current State

The City of Blue Island's wide area network is extremely inadequate for the technology needs of todays applications, media and connectivity. The City is currently operating on a Comcast minimal broadband speed with extremely minimal security and zero redundancy. Any future technology such as body cameras, increased virus threats, media applications, etc... will cripple our current network speeds.

Vendor List

The vendor list that has been put together considers two top- tier qualified economical solutions.

First Communications

Masergy

Both service providers have provided us great solutions, with Masergy being the front runner based on its overall proposal. Masergy's solution includes all new Fortinet firewalls, with unified threat management 24/7/365, the bandwidth we need with redundancy and security. These solutions are a monthly cost operating model. The solution pricing is below.

First Communications - Monthly Recurring Cost: \$14,440.00 w/ an install fee of \$2250.00

Masergy - Monthly Recurring Cost: \$8,440.89 w/ an install fee of \$0

The monthly recurring cost is based on a 36 month contract which is standard in the telecommunications industry.
