**A RESOLUTION OF THE CITY OF BLUE ISLAND,  
COOK COUNTY, ILLINOIS, TO AUTHORIZE AND APPROVE THE CITY'S  
APPLICATYION FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT  
PROGRAM YEAR 2023, CITY OF BLUE ISLAND IRVING AVENUE FROM 119<sup>TH</sup>  
STREET TO 121<sup>ST</sup> STREET**

**WHEREAS**, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12; and

**WHEREAS**, the City has elected to submit an application to Cook County for the Community Development Block Grant Program (CDBG) for Program Year 2023; and

**WHEREAS**, the Mayor and Aldermen of the City of Blue Island have considered and reviewed the Application and various forms considered therein for participation consideration in the CDBG Program Year 2023.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** That a Request is hereby made to the County of Cook, Illinois, for Community Development Block Grant ("CDBG") funds for Program Year 2023 in the amount of

\$320,160 for the following project, as identified in City of Blue Island CDBG Program Year 2023 application:

Project: City of Blue Island Irving Avenue Project

Total Project Cost: \$400,200

**Section 4.** That the Mayor and City Administration is hereby authorized to sign the application and various forms contained therein, make all required submissions, and do all things necessary to complete the application for the funds requested in Section 1 of this Resolution, a copy of which application is on file with the Secretary.

**Section 5.** That the Mayor is hereby authorized to certify that matching funds which have been identified as supporting its projects as set out within its application will be made available upon the approval of the projects by the County of Cook, Illinois, or the prorated share thereof

**Section 6.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

**Section 7.** All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 8.** This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.


