Ald. Donahue gave an update on the Western Avenue Bridge. There are three phases: planning, engineering, and construction. Currently we are on phase two with phase three construction expected to start in Fall 2016. The proposed improvements include the superstructure replacement, removal and replacement of the existing light poles and any attached utilities, construction of new south abutment as well as repairing existing abutment. Public Health & Safety Committee Report for the Meeting of December 8th, 2015

Present were Chief James Klinker, Deputy Chief Michael Cornell, Supervisor Jim McGeever, Alderman Nancy Thompson, Alderman James Johanson, Alderman George Poulos, Alderman Dexter Johnson, and myself. Absent were Director John Rita and Don Marchbanks. Mr. Allan Stevo was present as a citizen. The meeting was called to order at 6:00 p.m.

Approval of Previous Meetings Minutes

Motion by Alderman Thompson, second by Adlerman Poulos, all in favor, motion carried.

Citizens' Concerns

Mr. Allan Stevo asked if the Chairman could read his (Stevo's) concerns from the previous meeting.

Mr. Stevo asked if there was shooting recently in Blue Island on Walnut Street. The Deputy Chief answered that there was not, often the Police Department receives shots fired calls which are unfounded.

Mr. Stevo asked for the status on the shootings on Western Avenue last summer.

Mr. Stevo asked if the police officer that was arrested was on paid leave. No, he is not.

Mr. Stevo asked if the Police and Fire Departments have overspent their budgets.

Fire Department Report

The Fire Department had 271 calls in November, 185 were EMS calls

151 Patients were treated

139 Patients were transported

46 Patients refused transport

They responded to 17 general fire alarms, and 23 minor fire alarms.

They responded to 34 auto aid calls, most calls were from Calumet Park.

They had 11 calls to man the station.

They received 1 mutual aid response call.

Average response time was 5.6 minutes.

Medical Reimbursement Services for November was \$45,155.28

Fire Recovery paid \$0.00 in November.

False Fire Alarms Fees collected in November \$200.00

During the month of November the Fire Department was called out on one care fire, two stove fires, one structure fire, and one dryer fire at Blue Kangaroo.

General

Firefighter Pinnick passed his Probation.

The annual service testing of all ladders was completed.

The Fire Department performed an evacuation drill at MetroSouth Medical Center.

New ambulance 2152 passed Safety Lane and IDPH Inspection and was placed in service.

The Emergency Vehicle Blessing by Father Ken Carlson took place November 24, 2015. The blessing included the new ambulance, a new police cruiser, and a new BIHSEMA vehicle.

Police Department

As of December 1st, Commander Sisk was assigned to the 911 Center to help Supervisor McGeever update the training manuals and operating procedures. Dispatchers will be getting on the job training more frequently.

The Police Department answered 2307 calls including 701 business premise checks, 154 were liquor establishment checks.

Calls of Interest

On November 9, 2015 at 2023 hours, two people walking through the parking lot at United Liquors where approached by two offenders. One of the offenders approached with a gun and demanded "everything they got." The victims told the offenders "Look around, there are cameras everywhere." The offenders looked up and then fled the area. The case is being investigated.

On November 24, 2015 at 1810 hours Officers responded to Radio Shack to a Hold Up Alarm call. Upon arrival, Officers learned that the store employee pushed the alarm because two suspicious people walked into the store, one of which appeared to be concealing a gun.

Upon arrival, the employee pointed out the suspicious persons. Officers approached the subjects and one of the subjects attempted to hide a toy gun on the shelves. The other offender was handcuffed for safety, at which time

Officers recovered a gun in his pocket.

Both offenders were taken into custody and interviewed. Both offenders admitted they were going to rob the Radio Shack. They were charged with attempted Armed Robbery. In addition to our charges, both offenders were charged by other agencies.

Liquor Establishment Calls

There were one intoxicated subject call, one neighbor complaint call, two subject removal calls, two disturbance calls and one criminal damage to property call.

Training

Officer John McSweeney and Part-time Officer Andrew Martino attended an eight hour training course of Strategies and Tactics of Patrol Stops at Clarendon Hills Police Department.

Corporals Frank Navarro and Bernadine Rzab attended an eight hour training course of Juvenile Interrogation and Delinquency updates at Tinley Park Police Department.

Officer Erick Stahmer attended a Train the Trainer course at the Bolingbrook Police Department.

Community Policing Unit (CPU)

The Community Policing Unit completed lockdown drills at all the schools except Whittier which is scheduled in December.

The Community Policing Unit assisted Probationary Recruit Jeremy Rhodes with implementation into the Academy.

The Community Policing Unit responded to several calls regarding hospitalized seniors who needed assistance from family members.

The Community Policing Unit was requested to do a wellbeing check on a Lincoln student. It was determined that the Juvenile is residing outside the geographical limits of District 130.

The Community Policing Unit assisted the Building Department with an aggressive campaign to enforce all applicable building codes. They are currently working in the 7th Ward.

Events

The Fill-a-Cruiser Food Drive for Angel's Touch was held on December 5th, as was the Christmas Light Parade. Both were a success.

Rock Around the Clock will be held on December 31st, starting at 11:30 pm.

A Police Exam will be held January 9th. Applications are being taken until December 28th. This will be for a full time Officer.

911 Center

In November, the 911 Center answered a total of 7248 calls. Three dispatchers are currently in training.

Code Red Calls were sent concerning the Division Street Bridge closure and repair.

Commander Sisk is working with Supervisor McGeever on a 911 Center Manual.

Monthly Health and Sanitation Report

In the month of November 21 Health and Sanitation Inspections were done. International Hair Studio was closed due to licensing problems. Several businesses that may be operating illegally within the city limits are being monitored.
