ORDINANCE NO. 2015-008

AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, TO SET A DATE FOR A PUBLIC HEARING FOR THE WESTERN AVENUE BUSINESS DEVELOPMENT DISTRICT

BE IT ORDAINED by the Mayor and City Council of the City of Blue Island, Cook County, Illinois (the "City"), as follows:

Section 1. It is necessary and in the best interests of the City that a public hearing be held prior to the adoption of an ordinance or ordinances by the City Council approving the Western Avenue Business Development District Development Plan (the "Business District Plan"), establishing the Western Avenue Business Development District (the "Business District"), and imposing retailers' and service occupation taxes (the "Taxes"), in accordance with the Business District Development and Redevelopment Law, 65 ILCS 5/11-74.3-1, et seq. (the "Act").

Section 2. The proposed Business District includes all of the properties fronting Western Avenue on the east and west from 119th Street to 127th Street; the properties fronting 127th Street on the north from Western Avenue to Irving Avenue; the properties generally bounded on the north by 127th Street, on the east by the Railroad Right-of-Way, on the south by the intersection of the Railroad Right-of-Way and Western Avenue, and on the west by Western Avenue; the properties fronting Vermont Street on the north and south from the Railroad Right-of-Way to the east side of Division Street; the properties generally bounded on the north by Vermont Street, on the east by Chatham Street, on the south by Fulton Street, and on the west by the Railroad Right-of-Way; the properties generally bounded on the north by the Calumet–Saganashkee Channel, on the east by Western Avenue, on the south by 135th Street, and on the west by the properties fronting Old Western Avenue on the west, and including four parcels fronting Western Avenue on the east between Canal Street and Broadway Street; the properties

fronting Old Western Avenue on the east and west from the Calumet–Saganashkee Channel to Grove Street; the properties fronting Western Avenue on the west from Grove Street to Vermont Street; properties fronting Vermont Street on the north and south from Western Avenue to the west side of Greenwood Avenue; and all of the properties fronting Western Avenue on the west from Vermont Street to 127th Street.

Section 3. The Act grants the City the power to establish by ordinance procedures for the planning, execution and implementation of business district plans; and pursuant to the Act, the City desired to authorize the date for a public hearing (the "Public Hearing") on the proposed Business District Plan, proposed Business District, and the imposition of Taxes therein, and the publication of notice thereof.

Section 4. It is hereby determined that the Public Hearing shall be held by the Mayor and City Council of the City of Blue Island on the 10th day of March, 2015, at 6:30 p.m., at the City Hall, 13051 Greenwood Avenue, Blue Island, Illinois.

Section 5. Notice of the Public Hearing is hereby authorized to be given by publication in the SouthtownStar on February 23, 2015 and February 27, 2015 (not more than 30 nor less than 10 days prior to the date of the Public Hearing).

Section 6. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause, or provision shall not affect any of the other provisions of this Ordinance.

Enterprise Community Partners MOU 01/30/2015

1. Introduction and Purpose

Enterprise Community Partners (ECP) seeks to assist Blue Island with pre-development services in the Transit Oriented Development (TOD) District. ECP requires a municipal resolution as a demonstration of local support. This resolution authorizes the Mayor or staff to complete a Memorandum of Understanding (MOU) with ECP in order to begin services.

ECP is a national non-profit organization that provides expertise to local developer partners, leads policy work and initiatives, operates national programs such as Enterprise Green Communities and makes grants to partners to help them strengthen their operations or plan projects.

II. Discussion/Highlights

ECP was awarded grant funds from Chicago Community Trust to engage elected officials and staff in three south suburban communities. In Blue Island ECP seeks to support TOD projects within Uptown and the Vermont Street Station Area. Up to five redevelopment sites will be selected and a steering committee chosen to participate. There is no cost to the City for these services.

ECP will provide pre-development assistance, including site strategy, appraisals, marketing, financial analysis. ECP will assist the steering committee in evaluating the potential impacts of potential redevelopment, soliciting interest from the development community and determining, where appropriate, public policy variances and/or municipal financing commitment levels to be included as part of any development project.

III. Conclusion and Recommendation

Recommendation that City Council adopts resolution authorizing approval of a MOU with Enterprise Community Partners.

ORDINANCE NO. 2015-009

AN ORDINANCE RESTRICTING A PORTION OF A CERTAIN STREET AT OR NEAR 2451 COLLINS STREET FOR HANDICAPPED PARKING ONLY WITHIN THE CITY OF BLUE ISLAND, COUNTY OF COOK, STATE OF ILLINOIS, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, it is the public policy of the State of Illinois, as enunciated in the State Constitution, that handicapped persons are entitled to enjoy the fruits of a full and meaningful life; and

WHEREAS, the Mayor and City Council of the City of Blue Island hereby declare that it is the public policy of the city to encourage and assist handicapped persons to participate fully in the social and economic life of our community; and

WHEREAS, to implement such policy the Mayor and City Council of the City of Blue Island recognize it is desirable to restrict certain portions of the public ways within the City of Blue Island for handicapped parking only;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Blue Island, County of Cook and State of Illinois, as follows:

SECTION ONE

That this portion of the street within the City of Blue Island, as hereinafter designated, is hereby restricted for handicapped parking only:

a) On the south side of Collins Street in front of the residence whose common address is 2451 Collins Street (one space consisting of a total of twenty (20') feet)

SECTION TWO

Appropriate signs shall be erected by the Superintendent of Public Works on the portion of the street designated above informing the public that parking thereon is restricted or permitted as hereinabove provided for.

SECTION THREE

The operator of any vehicle violating or failing to comply with the provisions of this ordinance shall upon conviction be fined not less than Two Hundred Fifty Dollars (\$250.00) nor more than Three Hundred Fifty Dollars (\$350.00) for each offense.

SECTION FOUR

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION FIVE

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. A full, true and complete copy of this ordinance shall be published in pamphlet form, by authority of the City Council as Corporate Authorities.

If you can help, we assure you that this will make a difference in the lives of the 600 children and adults who call Misericordia "Home". They are persons of all races, religions and creeds with disabilities ranging from mild and moderate to severe and profound. Each of them is a gift to us and we are better people because they have touched our lives. The funds we receive from the State cover only a portion of our program costs. This year we must raise \$14 million to cover the cost of programs that are not reimbursed. Our excellent physical and occupational therapy programs and music would not be realities without private contributions. Our vocational, spiritual and recreational programs are also gifts from our friends.

Private donations have allowed us to expand to serve more persons in need. At the present time we have more than 500 people on our waiting list. We know we can never meet all the demands for service but with the help of our friends, we will continue to face the challenges associated with expansion. We have also started and will expand an outreach program for children with disabilities and their families.
