MAYOR'S ANNOUNCEMENT

The Mayor stated he wanted to thank Val Kehoe, students, and staff for planting 25 trees at or near the Eisenhower property with the help of Public Works and the Eisenhower administration.

The Mayor stated his office received a call 10/22/21 and Blue island in conjunction with the City of Chicago Water Commissioner and the Illinois EPA set up an emergency water

connection for the City of Dixmoor, whose existing water supply lost pressure and residents were without running water for seven days. The IGA between the communities is for a period of 30 days and requires payment from Dixmoor.

The Mayor stated H&H has replaced 384 street lights of 560 and hopes to be done with all street lights by the deadline.

The Deputy City Administrator Mark Patoska reviewed the upcoming health insurance renewal and proposed the potential elimination of the regular PPO plan and switch to Blue Choice PPO in order to save money; however, the City Keeps all current options, there will be an 0.8% increase in cost to the City for 2021.
