MAYOR'S ANNOUNCEMENT

The Mayor expressed his thoughts and prayers for the family of the Eisenhower student who was struck that morning. The police officers reached out and have said he is in stable condition with multiple injuries. This is the second student struck this year along 127th and Burr Oak. The Street is owned and maintained by the Illinois Department of Transportation. Blue Island has limited options on what the City can do on the street; however, the Mayor and administration were discussing the safety issue and would provide updates to the public and council.

Alderman Fahrenwald suggested speed cameras.

Alderman McGee suggested working with District 218 and further educating students on jaywalking.

The Mayor announced that he would be traveling with Treasurer Jairo Frausto and Alderman Luiz Montoya to their hometown, Villa Gonzalez Ortega, Zacatecas, where the vast majority of the City's Latino population comes from. During the visit, which the Mayor paid for personally, the plan was to sign a sister agreement to bridge the communities with educational, economic, and cultural opportunities.

The Mayor announced that as Covid-19 cases rise in the State of Illinois, he is encouraging his fellow residents and elected officials to mask up and get vaccinated to best protect themselves, families, and neighbors; and to ensure Blue Island's economic recovery. He urged that residents who have not been vaccinated, to consult their primary doctor. He also announced that effective August 23rd Cook County Department of Public Health mandated everyone two years and older to wear masks indoor and in public spaces. The Mayor believes that together we can do our part to combat the delta variant and make a full recovery.

CITY CLERK'S ANNOUNCEMENTS

City Clerk Raeann Cantelo-Zylman stated that all of the ordinances and resolutions have been added to the City of Blue Island website.

City Clerk Raeann Cantelo-Zylman spoke to Lakeshore about recycling old electronics.

City Clerk Raeann Cantelo-Zylman wants to change the hours of the Clerk's office. She will be taking any ideas and solutions and then will request consent from the council.

City Clerk Raeann Cantelo-Zylman reminded everyone that Dog Days is Saturday and Jackie Murphy will be heading the show.

City Clerk Raeann Cantelo-Zylman mentioned that residents are still buying city stickers and the police are doing a phenomenal job in enforcing the same.

The Mayor mentioned an increase of 600 more vehicle sticker sales than last year.

City Clerk Raeann Cantelo-Zylman mentioned that she would like to talk about dogs registration enforcement in the next meeting.

City Clerk Raeann Cantelo-Zylman stated there is going to be a block party on 9/5/2021 at 2508 Collins.

City Clerk Raeann Cantelo-Zylman stated that three businesses contributed to the "welcome bags". She will be sending an email to the council with more details.

Alderman Fahrenwald mentioned that he had received complaints about the city not answering the phones and the City Clerk stated she was surprised since she makes sure no messages are left every night; however, she was going to mention it to everyone.
